EXECUTIVE ORDER TO. /

WHEREAS, the State of Wisconsin's Outdoor Recreation Act Program was enacted in 1961 to acquire, maintain and develop for public use those areas of the State best adapted to the development of a comprehensive system of recreational facilities; and

WHEREAS, since 1961 the Outdoor Recreation Act Program has invested \$14.7 million in the public acquisition, enhancement, and protection of the State's outdoor recreation resources; and

WHEREAS, other State, Federal, and Local governmental recreation resources programs operate in a related and complementary fashion to the Outdoor Recreation Act Program, and should be carefully coordinated with that program; and

WHEREAS, the Outdoor Recreation Act Program concept, accomplishments and methods should be comprehensively reviewed to assess its 5-year experiences, to determine outdoor recreation resources needs in future years, to ensure its coordination with related recreation resources programs, and to modernize its aims and operations;

NOW, THEREFORE, I, WARREN P. KNOWLES, Covernor of the State of Wisconsin, do hereby establish the Governor's Task Force on the Outdoor Recreation Act Program as a staff committee and do appoint and constitute Leo W. Roethe, Clifford W. Krueger, Norman C. Anderson, Marvin Dillman, Alice Huck, Leonard I. Seyberth, Haskell Noyes, Jr., Kenneth P. Rutterfield, Mrs. Michael Stencil, James R. Smaby, Fred D. Hertley, Wayne Hood, John Ross, L. P. Voigt, Jack Olson, John Boyne, Ralph Hovind, Glen E. Pommerening, John M. Zancanero, Lloyd Owens, Mrs. Gordon R. Walker, and Phillip DeChant as members of said Task Force, hereby authorizing and empowering them to make such studies and investigations as they may consider necessary to comprehensively assess the Outdoor Recreation Act Program and related recreation resource programs and to propose the means and manner by which the State's outdoor recreation resources programs may be improved.

IN FUNTHERANCE UNERROUP, I charge every officer and employe of this State to furnish to the Task Force and its staff complete information required and requested by the Task Force, and I further charge the State Conservation Department, the State Department of Resource Development and the State Department of Administration to provide the Task Force with whatever staff assistance is required by the Task Force; and

UPON THE COMPLETION OF ITS WORK, I request that said Task Force shall render to me on December 15, 1966, a full report of its findings and such recommendations as said Committee shall deem appropriate in the premises.
