



1995 ASSEMBLY BILL 532

September 1, 1995 – Introduced by Representatives SKINDRUD, KAUFERT, ZUKOWSKI, SCHNEIDERS, GOETSCH, HAHN, GROTHMAN and SILBAUGH. Referred to Committee on Consumer Affairs.

1 **AN ACT to amend** 454.04 (1) (c), 454.06 (10) and 454.10 (4); and **to create** 454.06
2 (10) (b), (c) and (d) of the statutes; **relating to:** temporary licenses for
3 aestheticians, electrologists and manicurists.

Analysis by the Legislative Reference Bureau

Under current law, the barbering and cosmetology examining board (board) issues barber or cosmetologist licenses, aesthetician licenses, electrologist licenses and manicurist licenses. To be eligible for one of these licenses, a person must meet certain requirements, including education or experience requirements, and must pass an examination. However, the board may issue a 6-month, nonrenewable temporary permit to a person who is applying for a barber or cosmetologist license if the person has satisfied all the requirements for licensure except for the examination requirement and if the person is scheduled to take the examination.

This bill authorizes the board to issue a 6-month, nonrenewable temporary permit to a person who is applying for an aesthetician, electrologist or manicurist license if the person has satisfied all the requirements for licensure except for the examination requirement and the person is scheduled to take the examination.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

4 **SECTION 1.** 454.04 (1) (c) of the statutes is amended to read:

1 454.04 (1) (c) No person may engage in electrology unless the person holds a
2 current electrologist license, temporary permit or training permit issued by the
3 examining board or is a student in an electrology course of instruction.

4 **SECTION 2.** 454.06 (10) of the statutes is amended to read:

5 454.06 (10) (a) The examining board may issue a temporary permit to practice
6 as a barber or cosmetologist without examination if the applicant meets all of the
7 requirements of sub. (2) for licensure except passage of an examination and if the
8 applicant is scheduled to take the examination for licensure.

9 (e) A temporary permit issued under this subsection is valid for not more than
10 6 months and may not be renewed. The fee for a temporary permit issued under this
11 subsection is that specified in s. 440.05 (6).

12 **SECTION 3.** 454.06 (10) (b), (c) and (d) of the statutes are created to read:

13 454.06 (10) (b) The examining board may issue a temporary permit to practice
14 as an aesthetician without examination if the applicant meets all of the
15 requirements of sub. (4) for licensure except passage of an examination and if the
16 applicant is scheduled to take the examination for licensure.

17 (c) The examining board may issue a temporary permit to practice as an
18 electrologist without examination if the applicant meets all of the requirements of
19 sub. (5) for licensure except passage of an examination and if the applicant is
20 scheduled to take the examination for licensure.

21 (d) The examining board may issue a temporary permit to practice as a
22 manicurist without examination if the applicant meets all of the requirements of sub.
23 (6) for licensure except passage of an examination and if the applicant is scheduled
24 to take the examination for licensure.

25 **SECTION 4.** 454.10 (4) of the statutes is amended to read:
