



1997 ASSEMBLY BILL 530

September 16, 1997 - Introduced by JOINT COMMITTEE ON EMPLOYMENT RELATIONS.
Referred to Committee on Rules.

1 **AN ACT to amend** 111.825 (1) (a) of the statutes; **relating to:** changing the name
2 of the clerical and related collective bargaining unit to the administrative
3 support collective bargaining unit, ratification of the agreement negotiated
4 between the state of Wisconsin and the Wisconsin State Employees Union,
5 AFSCME Council 24, and its appropriate affiliated locals, AFL-CIO, for the
6 1997-99 biennium, covering employes in the administrative support collective
7 bargaining unit, and authorizing an expenditure of funds.

Analysis by the Legislative Reference Bureau

This proposal is introduced under section 111.92 (1) of the statutes. The proposal ratifies the collective bargaining contract for state employes in the clerical and related collective bargaining unit negotiated for the 1997-99 biennium under the state employment labor relations act. Currently, statutory program supplement appropriations fund the costs of collective bargaining agreements to the extent that they exceed budgeted costs. The proposal authorizes expenditure of moneys from those appropriations to fund the cost of this agreement.

In addition, the bill changes the name of the clerical and related collective bargaining unit to the administrative support collective bargaining unit.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

1 **SECTION 1.** 111.825 (1) (a) of the statutes is amended to read:

2 111.825 (1) (a) ~~Clerical and related~~ Administrative support.

3 **SECTION 2. Nonstatutory provisions.**

4 (1) AGREEMENT RATIFIED. The legislature ratifies the tentative agreement
5 negotiated for the 1997-99 biennium between the state of Wisconsin, department of
6 employment relations, and the Wisconsin State Employees Union, AFSCME Council
7 24, and its appropriate affiliated locals, AFL-CIO, covering employes in the former
8 clerical and related collective bargaining unit under subchapter V of chapter 111 of
9 the statutes, as approved by the employes of the former clerical and related collective
10 bargaining unit and approved and recommended by the joint committee on
11 employment relations and authorizes the necessary expenditure of moneys for
12 implementation from the appropriations made by section 20.865 (1) of the statutes,
13 subject to section 20.865 (intro.) of the statutes. The secretary of employment
14 relations shall file an official copy of the agreement, certified by the cochairpersons
15 of the joint committee on employment relations, with the secretary of state. No
16 formal or informal agreement between the parties which is not a part of the official
17 copy is deemed to be approved by the legislature under this act.

18 **SECTION 3. Effective date.**

19 (1) This act takes effect on the day following publication, except that those
20 provisions specifically identified as having other effective dates in the agreement

2 effective on the dates provided in that agreement.
