



1997 SENATE BILL 356

November 18, 1997 - Introduced by Senators MOEN, BRESKE, JAUCH and ZIEN, cosponsored by Representatives MUSSER, GOETSCH, DOBYNS, PLOUFF, PLALE, TRAVIS, BAUMGART, BRANDEMUEHL, KREUSER, SKINDRUD, RYBA, GRONEMUS, HASENOHRL, TURNER and BOYLE. Referred to Committee on Health, Human Services, Aging, Corrections, Veterans and Military Affairs.

1 **AN ACT to repeal** 20.485 (4) (qm); **to amend** 20.866 (1) (u); **to repeal and**
2 **recreate** 20.866 (1) (u); and **to create** 20.485 (4) (f) of the statutes; **relating**
3 **to:** the payment of principal and interest for veterans cemeteries and making
4 an appropriation.

Analysis by the Legislative Reference Bureau

Under current law, as enacted in 1997 Wisconsin Act 27 (the budget bill), the principal and interest payments for the costs incurred by the state in financing the acquisition, construction, development, enlargement or improvement of veterans cemeteries are paid out of the veterans trust fund. This bill requires that those principal and interest payments be paid out of the general fund.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

5 **SECTION 1.** 20.485 (4) (f) of the statutes is created to read:
6 20.485 (4) (f) *Repayment of principal and interest.* A sum sufficient to
7 reimburse s. 20.866 (1) (u) for the payment of principal and interest costs incurred
8 in financing the acquisition, construction, development, enlargement or
9 improvement of veterans cemeteries provided under s. 20.866 (2) (zm).

1 **SECTION 2.** 20.485 (4) (qm) of the statutes, as created by 1997 Wisconsin Act
2 27, is repealed.

3 **SECTION 3.** 20.866 (1) (u) of the statutes, as affected by 1997 Wisconsin Act 27,
4 section 726, is amended to read:

15 **SECTION 4.** 20.866 (1) (u) of the statutes, as affected by 1997 Wisconsin Act 27,
16 section 727, and 1997 Wisconsin Act (this act), is repealed and recreated to read:

3 **SECTION 5. Effective dates.** This act takes effect on the day after publication,
4 except as follows:

5 (1) The repeal and recreation of section 20.866 (1) (u) of the statutes takes effect
6 on July 1, 1999.
