



2013 ASSEMBLY BILL 244

June 13, 2013 - Introduced by Representatives KAUFERT, THIESFELDT, CZAJA, BARNES, MURPHY, SCHRAA, A. OTT, MURTHA, SPIROS, TITTL, BIES, T. LARSON, PRIDEMORE, KRUG, STEINEKE and ENDSLEY, cosponsored by Senators GROTHMAN, ELLIS and FARROW. Referred to Committee on Transportation.

1 **AN ACT to amend** 341.14 (6r) (b) 2., 341.14 (6r) (b) 9. b., 341.14 (6r) (c) and 341.14
2 (6r) (fm) 7.; and **to create** 20.485 (1) (gf), 25.40 (1) (a) 30., 341.14 (6r) (b) 15. and
3 341.14 (6r) (f) 62. of the statutes; **relating to:** special distinguishing
4 registration plates displaying the words In God We Trust and making an
5 appropriation.

Analysis by the Legislative Reference Bureau

Under current law, any group or organization may apply to the Department of Transportation for designation as an authorized special group. If the application is approved, members of the authorized special group may obtain special distinguishing license plates for certain vehicles, including automobiles and motor homes, that are owned or leased by special group members. A fee, in addition to the regular registration fee for the particular kind of vehicle, is charged for the issuance or reissuance of most special plates.

Before October 2, 1998, authorized special groups whose members may obtain special plates were specifically enumerated in state law. With certain exceptions, current law provides that specific enumeration in state law of authorized special groups is limited to those special groups enumerated before October 2, 1998.

This bill establishes an authorized special group specifically enumerated in state law for persons interested in obtaining special plates displaying the words "In God We Trust." In addition to the regular vehicle registration fee, special group members must pay a \$15 fee for issuance or reissuance of these special plates, which

fee is deposited into the veterans trust fund. Special group members must also annually include payment of \$25 that provides funds to the Department of Veterans Affairs for the care of residents of the Wisconsin veterans homes.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

1 **SECTION 1.** 20.485 (1) (gf) of the statutes is created to read:

2 20.485 (1) (gf) *Veterans home member care.* All moneys received under s. 341.14
3 (6r) (b) 15. for the care of the members of the Wisconsin veterans homes under s.
4 45.50.

5 **SECTION 2.** 25.40 (1) (a) 30. of the statutes is created to read:

6 25.40 (1) (a) 30. Moneys received under s. 341.14 (6r) (b) 15. that are deposited
7 into the general fund and credited to the appropriation account under s. 20.485 (1)
8 (gf).

9 **SECTION 3.** 341.14 (6r) (b) 2. of the statutes is amended to read:

10 341.14 (6r) (b) 2. An additional fee of \$15 shall be charged for the issuance or
11 reissuance of the plates for special groups specified under par. (f), except that no
12 additional fee may be charged under this subdivision for the issuance or reissuance
13 of the plates for special groups specified under par. (f) 1. to 32., 49. to 49s., 51., ~~or 56.,~~
14 or 62.

15 **SECTION 4.** 341.14 (6r) (b) 9. b. of the statutes is amended to read:

16 341.14 (6r) (b) 9. b. A fee of \$15 shall be charged for the issuance or reissuance
17 of a plate for the special group specified under par. (f) 15m. or 62. All moneys received
18 under this subd. 9. b. in excess of the initial costs of production of the special group

1 plate under par. (f) 15m. or \$23,700, whichever is less, shall be deposited in the
2 veterans trust fund.

3 **SECTION 5.** 341.14 (6r) (b) 15. of the statutes is created to read:

4 341.14 (6r) (b) 15. A voluntary payment of \$25 that is in addition to the fee
5 under subd. 9. b. shall be collected in connection with the issuance or renewal of a
6 plate issued on an annual basis for the special group specified under par. (f) 62. A
7 voluntary payment of \$50 that is in addition to the fee under subd. 9. b. shall be
8 collected in connection with the issuance or renewal of a plate issued on the biennial
9 basis for the special group specified under par. (f) 62. if the plate is issued or renewed
10 during the first year of the biennial registration period or \$25 for the issuance or
11 renewal if the plate is issued or renewed during the 2nd year of the biennial
12 registration period. No plate may be issued for the special group specified under par.
13 (f) 62. unless the voluntary payment under this subdivision is collected. All moneys
14 received under this subdivision in excess of \$23,700 or of the initial cost of production
15 of the special group plate under par. (f) 62., whichever is less, shall be deposited into
16 the general fund and credited to the appropriation account under s. 20.485 (1) (gf).
17 To the extent permitted under ch. 71, the voluntary payment under this subdivision
18 is deductible as a charitable contribution for purposes of the taxes under ch. 71.

19 **SECTION 6.** 341.14 (6r) (c) of the statutes is amended to read:

20 341.14 (6r) (c) Special group plates shall display the word "Wisconsin", the
21 name of the applicable authorized special group, a symbol representing the special
22 group, not exceeding one position, and identifying letters or numbers or both, not
23 exceeding 6 positions and not less than one position. Except as provided in this
24 paragraph, the department shall specify the design for special group plates, but the
25 department shall consult the president of the University of Wisconsin System before

1 specifying the word or symbol used to identify the special groups under par. (f) 35.
2 to 47., the secretary of natural resources before specifying the word or symbol used
3 to identify the special groups under par. (f) 50. and 59., the chief executive officer of
4 the professional football team and an authorized representative of the league of
5 professional football teams described in s. 229.823 to which that team belongs before
6 specifying the design for the applicable special group plate under par. (f) 55., the chief
7 trademark officer of Harley–Davidson Michigan, LLC before specifying the design
8 for the applicable special group plate under par. (f) 61r., the department of veterans
9 affairs before specifying the design for the special group plates under par. (f) 49d.,
10 49h., and 49s., and the department of tourism and chief executive officer of the
11 organization specified in par. (f) 55m. before specifying the design and word or
12 symbol used to identify the special group name for special group plates under par.
13 (f) 55m. Special group plates under par. (f) 50. shall be as similar as possible to
14 regular registration plates in color and design. Special group plates issued under
15 par. (f) 62. shall display the words “In God We Trust”. The department shall make
16 available 2 designs for the special group plates under par. (f) 60. The department
17 may not specify any design for the special group plates under par. (f) 60. unless the
18 design is approved by the executive vice president of the Milwaukee Brewers
19 Baseball Club LP. The word or symbol used to identify the special group under par.
20 (f) 59. shall be different from the word or symbol used to identify the special group
21 under par. (f) 50. and the design shall cover the entire plate. Special group plates
22 under par. (f) 61m. shall display a logo or image of the lion associated with the Lions
23 Clubs International. Special group plates under par. (f) 61r. shall display a bar and
24 shield logo associated with Harley–Davidson, Inc., on the left portion of the plates
25 and the words “share the road” on the bottom portion of the plates. Notwithstanding

1 par. (e), special group plates under par. (f) 33m. and 48m. shall be the same color and
2 design that was specified by the department for special group plates under par. (f)
3 33. and 48., respectively, immediately prior to January 1, 2007. The design for
4 special group plates under par. (f) 33. and 48. shall be different from the design of
5 special group plates under par. (f) 33m. and 48m., respectively.

6 **SECTION 7.** 341.14 (6r) (f) 62. of the statutes is created to read:

7 341.14 **(6r)** (f) 62. Persons interested in obtaining registration plates with the
8 words "In God We Trust" on them.

9 **SECTION 8.** 341.14 (6r) (fm) 7. of the statutes is amended to read:

10 341.14 **(6r)** (fm) 7. After October 1, 1998, additional authorized special groups
11 may only be special groups designated by the department under this paragraph. The
12 authorized special groups enumerated in par. (f) shall be limited solely to those
13 special groups specified under par. (f) on October 1, 1998. This subdivision does not
14 apply to the special groups specified under par. (f) 3m., 6m., 9g., 9m., 12g., 12m.,
15 15m., 19m., 33m., 48m., 49d., 49h., 49s., 54., 55., 55m., 56., 57., 58., 59., 60., 61., 61m.,

17 **SECTION 9. Nonstatutory provisions.**

18 (1) Notwithstanding section 16.42 (1) (e) of the statutes, if this subsection takes
19 effect in fiscal year 2014-15, in submitting information under section 16.42 of the
20 statutes for purposes of the 2015-17 biennial budget bill, the department of
21 transportation shall submit information concerning the appropriation under section
22 20.395 (5) (cq) of the statutes as though the total amount appropriated under section
23 20.395 (5) (cq) of the statutes for the 2014-15 fiscal year was \$23,700 less than the
24 total amount that was actually appropriated under section 20.395 (5) (cq) of the
25 statutes for the 2014-15 fiscal year.

(1) In the schedule under section 20.005 (3) of the statutes for the appropriation to the department of transportation under section 20.395 (5) (cq) of the statutes, as affected by the acts of 2013, the dollar amount is increased by \$23,700 for the fiscal year in which this subsection takes effect to increase funding for special registration plates displaying the words "In God We Trust."

SECTION 11. Effective date.

(1) This act takes effect on the first day of the 5th month beginning after publication.
