1 **AN ACT** *to repeal* 118.045 and 118.38 (1) (a) 8.; and *to amend* 119.04 (1) of the
2 statutes; **relating to:** the commencement of fall classes in public schools.

Analysis by the Legislative Reference Bureau

With certain exceptions, current law prohibits a school district from beginning fall classes until September 1. Beginning in the 2018-19 school year, this bill eliminates this prohibition.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

4 **SECTION 2.** 118.38 (1) (a) 8. of the statutes is repealed.
