## 2019 ASSEMBLY JOINT RESOLUTION 98

November 4, 2019 - Introduced by Representatives SPREITZER, RIEMER, ANDERSON, BOWEN, CROWLEY, GOYKE, GRUSZYNSKI, HEBL, HINTZ, KOLSTE, MCGUIRE, MILROY, NEUBAUER, POPE, SHANKLAND, SINICKI, STUBBS, STUCK, SUBECK, C. TAYLOR, TUSLER, VRUWINK and ZAMARRIPA, cosponsored by Senators CARPENTER, WIRCH, LARSON and RISSER. Referred to Committee on Rules.

1     **Relating to:** commending the exemplary life and service of Justice John Paul  
2           Stevens.

3           Whereas, Supreme Court Justice John Paul Stevens was born April 20, 1920,  
4     in Chicago, Illinois, and passed on July 16, 2019; and

5           Whereas, Justice Stevens graduated with honors from the University of  
6     Chicago; and

7           Whereas, Justice Stevens left his studies to serve his country in the United  
8     States Navy, enlisting on December 6th, 1941, earning the rank of Lieutenant  
9     Commander and receiving a Bronze Star for his exceptional service; and

10          Whereas, upon the conclusion of his service, Justice Stevens returned to  
11     Illinois, began studying law at the Northwestern University School of Law, and  
12     graduated with the highest GPA in the history of the school in 1947; and

13          Whereas, Justice Stevens became a leading expert in antitrust laws, working  
14     against monopoly overreach in industries across the country including serving as

1 associate counsel to an antitrust subcommittee of the United States House of  
2 Representatives; and

3       Whereas, Justice Stevens was a diligent litigator who was called upon to  
4 investigate corruption in the Illinois Supreme Court, resulting in the prosecution of  
5 both the former Chief Justice and then-current Chief Justice of the Illinois Supreme  
6 Court; and

7       Whereas, Justice Stevens was appointed to the Seventh Circuit Court of  
8 Appeals by President Richard Nixon in 1970, where he served until being nominated  
9 for the Supreme Court of the United States by President Gerald Ford and  
10 unanimously approved by the United States Senate in 1975; and

11       Whereas, Justice Stevens served as a model for all justices as his quiet humility  
12 outside of the Supreme Court Chambers was paired with intense, deliberate  
13 questioning that challenged all of those who came before the court and followed by  
14 fearless dissenting opinions that were first drafted by Justice Stevens rather than  
15 by a clerk; and

16       Whereas, Justice Stevens's history of thorough briefs included notable  
17 decisions such as majority opinions in *Chevron U.S.A., Inc. v. Natural Resources*  
18 *Defense Council, Inc.*, *Clinton v. Jones*, *Clinton v. City of New York*, *Ferguson v. City*  
19 *of Charleston*, *Atkins v. Virginia*, *Watchtower Bible & Tract Society of New York, Inc.*  
20 *v. Village of Stratton*, *Rasul v. Bush*, *Hamdan v. Rumsfeld*, and *Massachusetts v.*  
21 *Environmental Protection Agency*, as well as his detailed and rigorous dissents in  
22 *Bowers v. Hardwick*, *Texas v. Johnson*, *Bush v. Gore*, and *District of Columbia v.*  
23 *Heller*, as well as his concurrence/dissents in *Planned Parenthood v. Casey* and  
24 *Citizens United v. Federal Election Commission*; now, therefore, be it

1           ***Resolved by the assembly, the senate concurring, That*** the members of the  
2 Wisconsin legislature recognize the exemplary service Justice John Paul Stevens  
3 rendered to our country through his sustained diligence and belief in the ability of  
4 the United States to strive to meet the lofty ideals laid out in our Constitution.
