2019 SENATE BILL 214

May 15, 2019 - Introduced by Senators JACQUE, RISSER, ERPENBACH, FEYEN, MILLER, WIRCH and OLSEN, cosponsored by Representatives THIESFELDT, HEBL, HESSELBEIN, POPE, ROHRKASTE, SKOWRONSKI, C. TAYLOR and VRUWINK. Referred to Committee on Insurance, Financial Services, Government Oversight and Courts.

1 **AN ACT** *to repeal* 800.14 (2); *to renumber* 343.301 (1m) and 814.61 (5); *to*
2 *renumber and amend* 800.085 (2), 800.095 (3) and 800.14 (4); *to amend* 49.90
3 (12), 49.90 (13) (c), 66.0113 (1) (b) 6., 66.0113 (1) (b) 7. b., 303.18 (2), 755.01 (1),
4 755.01 (4), 755.17 (1m), 755.17 (2), 799.29 (2), 800.035 (2) (e), 800.035 (5) (a),
5 800.035 (5) (c), 800.05 (3), 800.06 (1), 800.093 (1) (b), 800.095 (6), 800.095 (7),
6 800.115 (4), 800.115 (5), 800.13 (1), 800.14 (1), 800.14 (3), 800.14 (5), 806.10 (1)

10 municipal ordinance enforcement and court procedures.

Analysis by the Legislative Reference Bureau

This bill makes various changes to municipal ordinance enforcement and municipal court procedures, including the following: the bill outlines the procedure for the formation or dissolution of joint municipal courts; the bill specifies that municipal court budgets must be separate from, or appear on a separate line item from municipal prosecuting attorneys and municipal law enforcement agencies; the

bill allows for non-OWI municipal citations from an OWI offense to be tried with the OWI offense in circuit court; the bill outlines when proceedings in municipal court may be held by audiovisual means; the bill clarifies the procedure and fees required for an appeal from a municipal court judgment; the bill requires each municipal court to have an armed guard unless the judge orders otherwise; and the bill specifies that no municipal court clerk may appear in attire that suggests he or she is a law enforcement officer or employee of a law enforcement agency.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

1 **SECTION 1.** 49.90 (12) of the statutes is amended to read:

2 49.90 (12) The parent of a dependent person who maintains a child of the
3 dependent person under sub. (1) (a) 2. may, after the dependent person attains the
4 age of 18, apply to the circuit court for the county in which the child resides for an
5 order to compel restitution by the dependent person of the amount of maintenance
6 provided to the dependent person's child by that parent. The circuit court shall in
7 a summary way hear the allegations and proof of the parties and, after considering
8 the financial resources and the future ability of the dependent person to pay, may by
9 order specify a sum in payment of the restitution, to be paid weekly or monthly,
10 during a period fixed by the order or until further order of the court. Upon application
11 of any party affected by the order and following notice and an opportunity for
12 presentation of allegations and proof by the parties, the court may modify the order.
13 The parent of the dependent person may file a restitution order with the clerk of
14 circuit court. Upon payment of the fee under s. 814.61 (5) (a) (am) 1., the clerk of
15 circuit court shall enter the order on the judgment and lien docket under s. 806.10
16 in the same manner as for a judgment in a civil action. Thereafter, the parent of the

1 dependent person may enforce the order against the dependent person in the same
2 manner as for a judgment in a civil action.

3 **SECTION 2.** 49.90 (13) (c) of the statutes is amended to read:

4 49.90 (13) (c) If the parent of the dependent person specified in par. (a) provides
5 maintenance to the dependent person's child and if par. (b) applies, the parent may
6 apply to the circuit court for the county in which the child resides for an order to
7 compel restitution by the parent specified in par. (b) of the amount of maintenance
8 provided. The circuit court shall in a summary way hear the allegations and proof
9 of the parties and, after considering the financial resources and future ability of the
10 parent of the dependent person specified in par. (b) to pay, may by order specify a sum
11 in payment of the restitution, to be paid weekly or monthly, during a period fixed by
12 the order or until further order of the court. Upon application of any party affected
13 by the order and following notice and an opportunity for presentation of allegations
14 and proof by the parties, the court may modify the order. The parent specified in par.
15 (a) may file a restitution order with the clerk of circuit court. Upon payment of a fee
16 under s. 814.61 (5) ~~(a)~~ (am) 1., the clerk of circuit court shall enter the order on the

21 subsection is a coequal branch of the municipal government, subject to the
22 superintending authority of the supreme court, through the chief judge of the judicial
23 administrative district. A court shall become operative and function after January
24 1, 2011, when the city council, town board, or village board adopts an ordinance or
25 bylaw providing for the election of a judge and the operation and maintenance of the
