## 2021 ASSEMBLY BILL 790

January 4, 2022 - Introduced by Representatives HONG, S. RODRIGUEZ, SHELTON, ANDERSON, ANDRACA, BROSTOFF, CABRERA, CONLEY, CONSIDINE, EMERSON, HEBL, B. MEYERS, MILROY, NEUBAUER, OHNSTAD, POPE, SHANKLAND, SINICKI, SNODGRASS, SPREITZER, STUBBS, SUBECK, VINING and VRUWINK, cosponsored by Senators SMITH, AGARD, JOHNSON, ERPENBACH, ROYS, L. TAYLOR, LARSON and CARPENTER. Referred to Committee on Agriculture.

1     **AN ACT** *to create* 20.115 (3) (e) and 93.53 of the statutes; **relating to:** providing  
2             grants for food waste reduction pilot projects and making an appropriation.

***Analysis by the Legislative Reference Bureau***

The bill requires the Department of Agriculture, Trade and Consumer Protection to provide grants for food waste reduction pilot projects that have an objective of preventing food waste, redirecting surplus food to hunger relief organizations, and composting food waste. Under the bill, DATCP must give preference to grant proposals that serve census tracts for which the median household income is below the statewide median household income and in which no grocery store is located. The bill provides \$100,000 annually in general purpose revenue funding for this purpose.

3             **SECTION 1.** 20.005 (3) (schedule) of the statutes: at the appropriate place, insert

5 **SECTION 2.** 20.115 (3) (e) of the statutes is created to read:

6 20.115 (3) (e) *Food waste reduction grants.* The amounts in the schedule for  
7 providing food waste reduction grants under s. 93.53.

8 **SECTION 3.** 93.53 of the statutes is created to read:

9 **93.53 Food waste reduction grants.** (1) The department shall provide  
10 grants for food waste reduction pilot projects that have an objective of preventing  
11 food waste, redirecting surplus food to hunger relief organizations, and composting  
12 food waste. In awarding grants under this section, the department shall give  
13 preference to proposals that serve census tracts for which the median household  
14 income is below the statewide median household income and in which no grocery  
15 store is located.

16 (2) The department shall promulgate rules for the administration of this  
17 section.

18 **SECTION 4. Fiscal changes.**

19 (1) **SPECIAL EDUCATION AID.** In the schedule under s. 20.005 (3) for the  
20 appropriation to the department of public instruction under s. 20.255 (2) (b), the  
21 dollar amount for fiscal year 2021-22 is increased by \$64,000 and the dollar amount  
22 for fiscal year 2022-23 is increased by \$64,000, to increase funding for aids for special  
23 education under s. 115.88.

**ASSEMBLY BILL 790**

1           (2) UW SYSTEM; GENERAL PROGRAM OPERATIONS. In the schedule under s. 20.005  
2           (3) for the appropriation to the Board of Regents of the University of Wisconsin  
3           System under s. 20.285 (1) (a), the dollar amount for fiscal year 2021-22 is increased  
4           by \$16,000 and the dollar amount for fiscal year 2022-23 is increased by \$16,000, for  
5           the purpose for which the appropriation is made.
