Analysis by the Legislative Reference Bureau

This bill ratifies and enters Wisconsin into the PA Licensure Compact, which provides for the ability of a physician assistant (PA) to become eligible to practice in other compact states. Significant provisions of the compact include the following:

1. The creation of a PA Licensure Compact Commission, which includes one member or administrator of the licensure boards of each member state. The commission has various powers and duties granted in the compact, including establishing bylaws, promulgating binding rules for the compact, appointing officers and hiring employees, and establishing and electing an executive committee. The commission may levy on and collect an annual assessment from each member state or impose fees on licensees who receive compact privileges to cover the cost of the operations and activities of the commission and its staff.

2. The ability for a PA to obtain a “compact privilege,” which allows a PA who satisfies certain criteria to practice as a PA to provide medical services and other licensed activity to a patient located in another member state (remote state) under the remote state’s laws and regulations. The compact specifies a number of requirements in order for a PA to exercise a compact privilege, including holding a PA license in a member state, not having a felony or misdemeanor conviction, having had no revocation of a license or limitation or restriction on any license currently held due to an adverse action, and paying any fees and meeting any jurisprudence requirements that may be imposed by a remote state, though the bill does not impose any jurisprudence requirement. A remote state may, in accordance with that state’s laws, take adverse action against a PA’s compact privilege in the remote state and take any other necessary actions to protect the health and safety of its citizens. If the state in which a PA is licensed (home state) takes adverse action against a PA’s license, the PA loses the compact privilege in all remote states until certain criteria are satisfied. A member state may not impose discipline against a PA’s compact privilege or deny an application for a compact privilege in that member state for the individual’s otherwise lawful practice in another state.

3. The ability of member states to issue subpoenas that are enforceable in other states provided, however, that subpoenas may not be issued by a member state to gather evidence of conduct in another state that is lawful in that other state for the purpose of taking adverse action against a compact privilege or application for a compact privilege in that member state.

4. The creation of a coordinated data and reporting system containing licensure, adverse action, and the reporting of the existence of significant investigative information on PAs and applicants denied a PA license. The compact requires all adverse actions to be reported to the administrator of the data system. A member state must submit a uniform data set to the data system on all individuals to whom the compact is applicable as required by the rules of the commission.

5. Provisions regarding resolutions of disputes among member states and between member and nonmember states, including a process for termination of a state's membership in the compact if the state defaults on its obligations under the compact.

The compact becomes effective upon enactment by seven states. The compact provides that it may be amended upon enactment of an amendment by all member states. A state may withdraw from the compact by repealing the statute authorizing the compact, but the compact provides that a withdrawal does not take effect until 180 days after the enactment of that repeal.

CHAPTER 448

SUBCHAPTER XIII

PA LICENSURE COMPACT

448.988 PA licensure compact. (1) PURPOSE. In order to strengthen access to medical services, and in recognition of the advances in the delivery of medical services, the participating states of the PA licensure compact have allied in common purpose to develop a comprehensive process that complements the existing authority of state licensing boards to license and discipline PAs and seeks to enhance the portability of a license to practice as a PA while safeguarding the safety of patients. This compact allows medical services to be provided by PAs, via the mutual recognition of the licensee's qualifying license by other compact participating states. This compact also adopts the prevailing standard for PA licensure and affirms that the practice and delivery of medical services by the PA occurs where the patient is located at the time of the patient encounter, and therefore requires the PA to be under the jurisdiction of the state licensing board where the patient is located. State licensing boards that participate in this compact retain the jurisdiction to impose adverse action against a compact privilege in that state issued to a PA through the procedures of this compact. The PA licensure compact will alleviate burdens for military families by allowing active duty military personnel and their spouses to obtain a compact privilege based on having an unrestricted license in good standing from a participating state.

(2) DEFINITIONS. In this compact:

(a) "Adverse action" means any administrative, civil, equitable, or criminal action permitted by a state's laws which is imposed by a licensing board or other authority against a PA license or license application or compact privilege such as

6 under the remote state's laws and regulations.

8 felony or misdemeanor offense through adjudication or entry of a plea of guilt or no
9 contest to the charge by the offender

10 (d) "Criminal background check" means the submission of fingerprints or other
11 biometric-based information for a license applicant for the purpose of obtaining that
12 applicant's criminal history record information, as defined in 28 CFR 20.3 (d), from
13 the state's criminal history record repository as defined in 28 CFR 20.3 (f).

14 (e) "Data system" means the repository of information about licensees,
15 including but not limited to license status and adverse actions, which is created and
16 administered under the terms of this compact.

18 elected or appointed pursuant to sub. (7) (f) 2.

19 (g) "Impaired practitioner" means a PA whose practice is adversely affected by
20 health-related condition(s) that impact their ability to practice.

21 (h) "Investigative information" means information, records, or documents
22 received or generated by a licensing board pursuant to an investigation.

23 (i) "Jurisprudence requirement" means the assessment of an individual's
24 knowledge of the laws and rules governing the practice of a PA in a state.

1 (j) “License” means current authorization by a state, other than authorization
2 pursuant to a compact privilege, for a PA to provide medical services, which would
3 be unlawful without current authorization.

4 (k) “Licensee” means an individual who holds a license from a state to provide
5 medical services as a PA.

6 (L) “Licensing board” means any state entity authorized to license and
7 otherwise regulate PAs.

8 (m) “Medical services” means health care services provided for the diagnosis,
9 prevention, treatment, cure or relief of a health condition, injury, or disease, as
10 defined by a state’s laws and regulations.

11 (n) “Model compact” means the model for the PA licensure compact on file with
12 the Council of State Governments or other entity as designated by the commission.

13 (o) “Participating state” means a state that has enacted this compact.

14 (p) “PA” means an individual who is licensed as a physician assistant in a state.
15 For purposes of this compact, any other title or status adopted by a state to replace
16 the term “physician assistant” shall be deemed synonymous with “physician
17 assistant” and shall confer the same rights and responsibilities to the licensee under
18 the provisions of this compact at the time of its enactment.

19 (q) “PA licensure compact commission,” “compact commission,” or
20 “commission” mean the national administrative body created pursuant to sub. (7) (a).

21 (r) “Qualifying license” means an unrestricted license issued by a participating
22 state to provide medical services as a PA.

23 (s) “Remote state” means a participating state where a licensee who is not
24 licensed as a PA is exercising or seeking to exercise the compact privilege.

1 (t) "Rule" means a regulation promulgated by an entity that has the force and
2 effect of law.

3 (u) "Significant investigative information" means investigative information
4 that a licensing board, after an inquiry or investigation that includes notification and
5 an opportunity for the PA to respond if required by state law, has reason to believe
6 is not groundless and, if proven true, would indicate more than a minor infraction.

7 (v) "State" means any state, commonwealth, district, or territory of the United
8 States.

9 **(3) STATE PARTICIPATION IN THIS COMPACT.** (a) To participate in this compact, a
10 participating state shall:

11 1. License PAs.

12 2. Participate in the compact commission's data system.

13 3. Have a mechanism in place for receiving and investigating complaints
14 against licensees and license applicants.

15 4. Notify the commission, in compliance with the terms of this compact and
16 commission rules, of any adverse action against a licensee or license applicant and
17 the existence of significant investigative information regarding a licensee or license
18 applicant.

19 5. Fully implement a criminal background check requirement, within a time
20 frame established by commission rule, by its licensing board receiving the results of
21 a criminal background check and reporting to the commission whether the license
22 applicant has been granted a license.

23 6. Comply with the rules of the compact commission.

24 7. Utilize passage of a recognized national exam such as the NCCPA PANCE
25 as a requirement for PA licensure.

1 8. Grant the compact privilege to a holder of a qualifying license in a
2 participating state.

3 (b) Nothing in this compact prohibits a participating state from charging a fee
4 for granting the compact privilege.

5 **(4) COMPACT PRIVILEGE.** (a) To exercise the compact privilege, a licensee must:

6 1. Have graduated from a PA program accredited by the Accreditation Review
7 Commission on Education for the Physician Assistant, Inc. or other programs
8 authorized by commission rule.

9 2. Hold current NCCPA certification.

10 3. Have no felony or misdemeanor conviction.

11 4. Have never had a controlled substance license, permit, or registration
12 suspended or revoked by a state or by the United States drug enforcement
13 administration.

14 5. Have a unique identifier as determined by commission rule.

15 6. Hold a qualifying license.

16 7. Have had no revocation of a license or limitation or restriction on any license
17 currently held due to an adverse action.

18 8. If a licensee has had a limitation or restriction on a license or compact
19 privilege due to an adverse action, two years must have elapsed from the date on
20 which the license or compact privilege is no longer limited or restricted due to the
21 adverse action.

22 9. If a compact privilege has been revoked or is limited or restricted in a
23 participating state for conduct that would not be a basis for disciplinary action in a
24 participating state in which the licensee is practicing or applying to practice under
25 a compact privilege, that participating state shall have the discretion not to consider

1 such action as an adverse action requiring the denial or removal of a compact
2 privilege in that state.

3 10. Notify the compact commission that the licensee is seeking the compact
4 privilege in a remote state.

5 11. Meet any jurisprudence requirement of a remote state in which the licensee
6 is seeking to practice under the compact privilege and pay any fees applicable to
7 satisfying the jurisprudence requirement.

8 12. Report to the commission any adverse action taken by a nonparticipating
9 state within thirty (30) days after the action is taken.

10 (b) The compact privilege is valid until the expiration or revocation of the
11 qualifying license unless terminated pursuant to an adverse action. The licensee
12 must also comply with all of the requirements of par. (a) above to maintain the
13 compact privilege in a remote state. If the participating state takes adverse action
14 against a qualifying license, the licensee shall lose the compact privilege in any
15 remote state in which the licensee has a compact privilege until all of the following
16 occur:

17 1. The license is no longer limited or restricted; and

18 2. Two (2) years have elapsed from the date on which the license is no longer
19 limited or restricted due to the adverse action.

20 (c) Once a restricted or limited license satisfies the requirements of par. (b) 1.
21 and 2., the licensee must meet the requirements of par. (a) to obtain a compact
22 privilege in any remote state.

23 (d) For each remote state in which a PA seeks authority to prescribe controlled
24 substances, the PA shall satisfy all requirements imposed by such state in granting
25 or renewing such authority.

1 **(5) DESIGNATION OF THE STATE FROM WHICH LICENSEE IS APPLYING FOR A COMPACT**
2 PRIVILEGE. (a) Upon a licensee's application for a compact privilege, the licensee shall

4 applying, in accordance with applicable rules adopted by the commission, and
5 subject to the following requirements:

6 1. When applying for a compact privilege, the licensee shall provide the
7 commission with the address of the licensee's primary residence and thereafter shall

10 2. When applying for a compact privilege, the licensee is required to consent
11 to accept service of process by mail at the licensee's primary residence on file with

15 **(6) ADVERSE ACTIONS.** (a) A participating state in which a licensee is licensed
16 shall have exclusive power to impose adverse action against the qualifying license
17 issued by that participating state.

18 (b) In addition to the other powers conferred by state law, a remote state shall
19 have the authority, in accordance with existing state due process law, to do all of the
20 following:

21 1. Take adverse action against a PA's compact privilege within that state to
22 remove a licensee's compact privilege or take other action necessary under applicable
23 law to protect the health and safety of its citizens.

24 2. Issue subpoenas for both hearings and investigations that require the
25 attendance and testimony of witnesses as well as the production of evidence.

2 testimony of witnesses or the production of evidence from another participating state
3 shall be enforced in the latter state by any court of competent jurisdiction, according

5 proceedings pending before it. The issuing authority shall pay any witness fees,
6 travel expenses, mileage and other fees required by the service statutes of the state
7 in which the witnesses or evidence are located.

10 for the purpose of taking adverse action against a licensee's compact privilege or

13 against a PA's compact privilege or to deny an application for a compact privilege in
14 that participating state for the individual's otherwise lawful practice in another
15 state.

16 (c) For purposes of taking adverse action, the participating state which issued
17 the qualifying license shall give the same priority and effect to reported conduct
18 received from any other participating state as it would if the conduct had occurred
19 within the participating state which issued the qualifying license. In so doing, that
20 participating state shall apply its own state laws to determine appropriate action.

21 (d) A participating state, if otherwise permitted by state law, may recover from
22 the affected PA the costs of investigations and disposition of cases resulting from any
23 adverse action taken against that PA.

1 (e) A participating state may take adverse action based on the factual findings
2 of a remote state, provided that the participating state follows its own procedures for

4 (f) *Joint investigations.* 1. In addition to the authority granted to a

6 state law, any participating state may participate with other participating states in
7 joint investigations of licensees.

8 2. Participating states shall share any investigative, litigation, or compliance
9 materials in furtherance of any joint or individual investigation initiated under this
10 compact.

11 (g) If an adverse action is taken against a PA's qualifying license, the PA's
12 compact privilege in all remote states shall be deactivated until two (2) years have
13 elapsed after all restrictions have been removed from the state license. All
14 disciplinary orders by the participating state which issued the qualifying license that
15 impose adverse action against a PA's license shall include a statement that the PA's
16 compact privilege is deactivated in all participating states during the pendency of the
17 order.

18 (h) If any participating state takes adverse action, it promptly shall notify the
19 administrator of the data system.

20 **(7) ESTABLISHMENT OF THE PA LICENSURE COMPACT COMMISSION.** (a) The
21 participating states hereby create and establish a joint government agency and
22 national administrative body known as the PA licensure compact commission. The
23 commission is an instrumentality of the compact states acting jointly and not an
24 instrumentality of any one state. The commission shall come into existence on or
25 after the effective date of the compact as set forth in sub. (11) (a).

1 (b) *Membership, voting, and meetings.* 1. Each participating state shall have
2 and be limited to one (1) delegate selected by that participating state's licensing
3 board or, if the state has more than one licensing board, selected collectively by the

6 a. A current PA, physician or public member of a licensing board or PA

23 1. Establish a code of ethics for the commission;

24 2. Establish the fiscal year of the commission;

25 3. Establish fees;

- 2 5. Maintain its financial records in accordance with the bylaws;
- 3 6. Meet and take such actions as are consistent with the provisions of this
4 compact and the bylaws;

6 administration of this compact. The rules shall have the force and effect of law and
7 shall be binding in all participating states;
- 8 8. Bring and prosecute legal proceedings or actions in the name of the
9 commission, provided that the standing of any state licensing board to sue or be sued
10 under applicable law shall not be affected;
- 11 9. Purchase and maintain insurance and bonds;
- 12 10. Borrow, accept, or contract for services of personnel, including, but not
13 limited to, employees of a participating state;

16 out the purposes of this compact, and establish the commission's personnel policies

6 state regulators, state legislators or their representatives, and consumer
7 representatives, and such other interested persons as may be designated in this
8 compact and the bylaws;

9 18. Provide and receive information from, and cooperate with, law enforcement
10 agencies;

11 19. Elect a chair, vice chair, secretary and treasurer and such other officers of
12 the commission as provided in the commission's bylaws.

13 20. Reserve for itself, in addition to those reserved exclusively to the
14 commission under the compact, powers that the executive committee may not
15 exercise;

16 21. Approve or disapprove a state's participation in the compact based upon its
17 determination as to whether the state's compact legislation departs in a material
18 manner from the model compact language;

7 3. The commission may convene in a closed, nonpublic meeting or nonpublic

11 b. The employment, compensation, discipline or other matters, practices or
12 procedures related to specific employees or other matters related to the commission's
13 internal personnel practices and procedures;

15 d. Negotiation of contracts for the purchase, lease, or sale of goods, services, or
16 real estate;

17 e. Accusing any person of a crime or formally censuring any person;

18 f. Disclosure of trade secrets or commercial or financial information that is

20 g. Disclosure of information of a personal nature where disclosure would

22 h. Disclosure of investigative records compiled for law enforcement purposes;

1 responsibility of investigation or determination of compliance issues pursuant to this
2 compact;

3 j. Legal advice; or

4 k. Matters specifically exempted from disclosure by federal or participating
5 states' statutes.

6 4. If a meeting, or portion of a meeting, is closed pursuant to this provision, the
7 chair of the meeting or the chair's designee shall certify that the meeting or portion
8 of the meeting may be closed and shall reference each relevant exempting provision.

9 5. The commission shall keep minutes that fully and clearly describe all
10 matters discussed in a meeting and shall provide a full and accurate summary of
11 actions taken, including a description of the views expressed. All documents
12 considered in connection with an action shall be identified in such minutes. All
13 minutes and documents of a closed meeting shall remain under seal, subject to
14 release by a majority vote of the commission or order of a court of competent
15 jurisdiction.

16 (e) *Financing of the commission.* 1. The commission shall pay, or provide for
17 the payment of, the reasonable expenses of its establishment, organization, and
18 ongoing activities.

19 2. The commission may accept any and all appropriate revenue sources,
20 donations, and grants of money, equipment, supplies, materials, and services.

21 3. The commission may levy on and collect an annual assessment from each
22 participating state and may impose compact privilege fees on licensees of

1 year for which revenue is not provided by other sources. The aggregate annual
2 assessment amount levied on participating states shall be allocated based upon a

4 a. A compact privilege expires when the licensee's qualifying license in the
5 participating state from which the licensee applied for the compact privilege expires.

6 b. If the licensee terminates the qualifying license through which the licensee
7 applied for the compact privilege before its scheduled expiration, and the licensee
8 has a qualifying license in another participating state, the licensee shall inform the
9 commission that it is changing to that participating state the participating state
10 through which it applies for a compact privilege and pay to the commission any
11 compact privilege fee required by commission rule.

12 4. The commission shall not incur obligations of any kind prior to securing the

21 report of the financial review shall be included in and become part of the annual
22 report of the commission.

23 (f) *The executive committee.* 1. The executive committee shall have the power
24 to act on behalf of the commission according to the terms of this compact and
25 commission rules.

- 1 2. The executive committee shall be composed of nine (9) members:

8 8. The executive committee may convene in a closed, nonpublic meeting for the
9 same reasons that the commission may convene in a nonpublic meeting as set forth
10 in par. (d) 3. and shall announce the closed meeting as the commission is required
11 to under par. (d) 4. and keep minutes of the closed meeting as the commission is
12 required to under par. (d) 5.

13 (g) *Qualified immunity, defense, and indemnification.* 1. The members,
14 officers, executive director, employees and representatives of the commission shall
15 be immune from suit and liability, both personally and in their official capacity, for
16 any claim for damage to or loss of property or personal injury or other civil liability
17 caused by or arising out of any actual or alleged act, error, or omission that occurred,
18 or that the person against whom the claim is made had a reasonable basis for
19 believing occurred within the scope of commission employment, duties or
20 responsibilities; provided that nothing in this subdivision shall be construed to
21 protect any such person from suit or liability for any damage, loss, injury, or liability
22 caused by the intentional or willful or wanton misconduct of that person. The
23 procurement of insurance of any type by the commission shall not in any way
24 compromise or limit the immunity granted hereunder.

1 2. The commission shall defend any member, officer, executive director,

19 4. Venue is proper and judicial proceedings by or against the commission shall
20 be brought solely and exclusively in a court of competent jurisdiction where the
21 principal office of the commission is located. The commission may waive venue and
22 jurisdictional defenses in any proceedings as authorized by commission rules.

23 5. Nothing herein shall be construed as a limitation on the liability of any
24 licensee for professional malpractice or misconduct, which shall be governed solely
25 by any other applicable state laws.

2 bring actions for alleged acts of malpractice, professional misconduct, negligence, or

13 containing licensure, adverse action, and the reporting of the existence of significant
14 investigative information on all licensed PAs and applicants denied a license in
15 participating states.

16 (b) Notwithstanding any other state law to the contrary, a participating state
17 shall submit a uniform data set to the data system on all PAs to whom this compact
18 is applicable (utilizing a unique identifier) as required by the rules of the

- 20 1. Identifying information;

- 22 3. Adverse actions against a license or compact privilege;
- 23 4. Any denial of application for licensure, and the reason(s) for such denial
24 (excluding the reporting of any criminal history record information where prohibited

2 6. Other information that may facilitate the administration of this compact, as
3 determined by the rules of the commission.

4 (c) Significant investigative information pertaining to a licensee in any

7 action taken against a licensee or an individual applying for a license that has been
8 reported to it. This adverse action information shall be available to any other
9 participating state.

10 (e) Participating states contributing information to the data system may, in
11 accordance with state or federal law, designate information that may not be shared
12 with the public without the express permission of the contributing state.
13 Notwithstanding any such designation, such information shall be reported to the
14 commission through the data system.

15 (f) Any information submitted to the data system that is subsequently
