## SENATE AMENDMENT 4, TO SENATE BILL 571

February 1, 2024 - Offered by Senator Cabral-Guevara.

At the locations indicated, amend the bill as follows:

- 1. Page 3, line 2: after "institution" insert "or material created for the institution or a college, school, department, or functional equivalent of the institution by a student acting on behalf of or in conjunction with an employee of the institution to produce material for institutional purposes and for which the employee is responsible. "Institution–sponsored media" includes yearbooks.".
- **2.** Page 3, line 23: after "law" insert ", including a violation of s. 948.11 or copyright law".
  - **3.** Page 4, line 3: after that line insert:
- "6. Rejected by a student-editor or an all-student editorial board.".
- **4.** Page 5, line 9: after "media" insert "or, for an institution that imposes no such limitations, a statement to that effect".

- **5.** Page 5, line 10: after "section" insert ", except that this paragraph does not apply for an institution that demonstrates to the board that only students are involved in making editorial or publication decisions".
  - **6.** Page 6, line 4: after "college" insert "or material created for the technical college or a school, department, or functional equivalent of the technical college by a student acting on behalf of or in conjunction with an employee of the technical college to produce material for the technical college's purposes and for which the employee is responsible. "District board–sponsored media" includes yearbooks.".
- **7.** Page 6, line 25: after "law" insert ", including a violation of s. 948.11 or copyright law".
  - **8.** Page 7, line 3: after that line insert:
  - "6. Rejected by a student-editor or an all-student editorial board.".
- **9.** Page 8, line 9: after "media" insert "or, if the district board imposes no such limitations, a statement to that effect".
  - **10.** Page 8, line 10: after "section" insert ", except that this paragraph does not apply if the district board demonstrates to the board that only students are involved in making editorial or publication decisions".
    - **11.** Page 9, line 4: delete "6" and substitute "9".
- **12.** Page 9, line 7: delete "middle, junior high, or".
- **13.** Page 9, line 13: after "purposes." insert ""School-sponsored media" 21 includes yearbooks.".
- 14. Page 10, line 3: after "law" insert ", including a violation of s. 948.11 or copyright law".
