AN ACT to divide the County of St. Croix and organize the County of La Pointe.

Be it enacted by the Council and House of Representatives of the Territory of Wisconsin: SECTION 1. That all that district of country within the limits

of St. Croix county, as prescribed by an act organizing said county, approved January 9th, 1840, be and the same is hereby divided into two counties; beginning at the mouth of Muddy Island river, thence running in a direct line to Yellow Lake, and from thence to Lake Courterille, so to intersect the eastern boundary line at that place, of the county of St Croix, thence to the nearest point on the west fork of Montreal river, thence down said river to Lake Superior. All that portion of the St. Croix county as heretofore bounded, lying south of said lines, be and remain the county of St. Croix, and all the country lying north of said line, and within

SEC. 2. The county of La Pointe aforesaid, shall be organ-Point organiz- ized for all purposes of county government, and shall enjoy all the rights, privileges and powers of other counties within this Ter. ritory, and may elect their county officers at the next, or any future general election. And at the first election so held, the judges of election shall issue certificates of election, as the clerks of the board of commissioners are authorized to do in other counties; and either of said judges of election is hereby authorized to administer the oath of office to any person duly elected.

Attached to Crawford Co. for judicial purposes.

SEC. 3. The county of La Pointe shall remain attached to the county of Crawford for judicial purposes; and the treasurer of the county of La Pointe shall pay to the treasurer of the county of Crawford one eighth of all the taxes collected in said county for the purpose of defraying her portion of the expenses of holding the district courts of Crawford county, as long as the same shall remain attached for judicial purposes, to the county of Crawford.

- SEC. 4. The town of La Pointe shall be the seat of justice La Point the until there shall be one located elsewhere by three commissioners seat of justice. to be elected at any future election; notice for the election of aid commissioners having been given previous to such election.— And the said commissioners after having taken an oath to faithfuly discharge their duties, shall proceed to locate the seat of justice at such place as will be for the best interest and convenience of the inhabitants of said county: Provided, said seat of justice Provisor shall not be located upon the claim of any resident without his or her consent, if such claim shall not exceed three hundred and iwenty acres.
- The town of La Pointe is hereby declared a precinct Precinct estab SEC. 5. and the eturns for all district and territorial officers may be made lished. by mail, to the clerk of the board of county commissioners of Crawford county, any time within forty-five days from the holding of such election.

AN ACT concerning bridges across Milwaukee River in the town of Milwaukee.

Be it macted by the Council and House of Representatives of the Territory of Wisconsin:

SECTION. 1. That the Trustees of the east, the west and the south wirds of the town of Milwaukee, or of either of said wards, or the people who inhabit or shall hereafter inhabit the district of country included in said ward, or either of them, shall have the right Trustees may and authority to build, maintain, repair, rebuild and keep in oper-build & maination at he expense of said wards or either of them, bridges across the Milvaukee river, in the town of Milwaukee at the following places, to wit: A bridge from the foot of Cherry street on the west side of the river to Water street on the east side of the river: a bridge from the foot of Wisconsin street on the east side, to Spring street on the west side, and a bridge from the foot of Water street, near George D. Dousman's warehouse to Walker's Point, and are hereby authorized to levy and collect an annual tax in the same manner as other taxes are levied and collected in said wards sufficient to defray said expenses, not exceeding one half of one per cent. per annum, on the taxable property included in
