

## CHAPTER 256.

[Published April 2', 1863.]

AN ACT to authorize the board of supervisors of Crawford county to pass an ordinance allowing horses, mules or cattle to run at large upon unenclosed lands in said county.

*The people of the state of Wisconsin, represented in senate and assembly, do enact as follows :*

SECTION 1. The board of supervisors of Crawford county are hereby authorized to pass an ordinance allowing horses, mules or cattle to run at large upon lands in said county not enclosed by a lawful fence, with such restrictions as such board may deem proper; and said board may prescribe penalties for a violation of said ordinance, [ordinance,] not at variance with the constitution and laws of this state.

Authority to pass ordinance allowing cattle, &c., to run at large.

SECTION 2. Such ordinance and all changes made therein shall be published for three weeks successively, in some newspaper published in said county, before said ordinance shall take effect.

Ordinance to be published.

SECTION 3. This act shall take effect and be in force from and after its passage.

## CHAPTER 257.

[Published April 23, 1863.]

AN ACT giving the board of supervisors of La Fayette county authority to pass an ordinance allowing horses, mules, sheep or cattle to run at large upon unenclosed lands in said county.

*The people of the state of Wisconsin, represented in senate and assembly, do enact as follows :*

SECTION 1. The board of supervisors of La Fayette county are hereby authorized to pass an ordinance allowing horses, mules, sheep or cattle to run at large upon lands in said county not enclosed by a lawful fence, with such restrictions as to such board may seem proper; and said board may prescribe penalties for a

violation of said ordinance, not at variance with the constitution and laws of this state.

Ordinance to be published.

SECTION 2. Such ordinance and all changes made therein shall be published for three weeks, successively, in some weekly newspaper published in said county, before said ordinance shall take effect.

SECTION 3. This act shall take effect and be in force from and after its passage.

## CHAPTER 258.

[Published April 23, 1863.]

AN ACT to vacate a part of "Miller's addition" to Beaver Dam, in the county of Dodge.

*The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:*

Part vacated.

SECTION 1. So much of Miller's addition to Beaver Dam, in the county of Dodge, as lies east and north-east of the track of the La Crosse and Milwaukee railroad, and north and north-west of Spring street, is hereby vacated.

SECTION 2. This act shall take effect and be in force from and after its passage.

## CHAPTER 259.

[Published April 23, 1863.]

AN ACT to appropriate to A. M. Blair the sum of \$1200.

*The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:*

Appropriation for loss of property by riot.

SECTION 1. There is hereby appropriated to A. M. Blair, out of any money in the treasury not otherwise appropriated, the sum of twelve hundred dollars, in full
