

## CHAPTER 129.

[Published March 14, 1864.]

AN ACT to authorize the collection of taxes for volunteering purposes in the town of Westfield, Marquette county.

*The people of the state of Wisconsin, represented in senate and assembly, do enact as follows :*

Bounty tax may  
be collected.

SECTION 1. The town treasurer of the town of Westfield, Marquette county, is hereby authorized and directed to collect all the taxes which were voted on the taxable property in and for said town of Westfield, Marquette county, in accordance with and agreeably to the acts and provisions made at a special town meeting or election held in said town on the fourth day of February, A. D. 1864, for the purpose of raising bounties for volunteers: *provided*, that no tax shall be levied and collected for veteran volunteers credited to said town.

SECTION 2. This act shall take effect and be in force from and after its passage.

## CHAPTER 130.

[Published March 14, 1864.]

AN ACT to authorize the collection of a special tax in the town of Aurora, in the county of Waushara.

*The people of the state of Wisconsin, represented in senate and assembly, do enact as follows :*

Bounty tax may  
be collected.

SECTION 1. The tax voted at a special town meeting held in and for the town of Aurora, in the county of Waushara, on the 27th day of February, 1864, for the purpose of paying bounties to volunteers, may be collected, and the delinquent portion thereof returned, in the manner prescribed by sections three, four, five, six, seven and eight of chapter thirty-nine of the general laws of 1864, and with the same force and effect as if said meeting had been called and held as provided by said chapter thirty-nine, prior to the 25th of February,

1864, anything in said chapter thirty-nine to the contrary notwithstanding.

SECTION 2. This act shall take effect and be in force from and after its passage.

CHAPTER 133.

[Published March 17, 1864.]

AN ACT to authorize certain towns in Juneau county to raise money by tax, for the construction of a road.

*The people of the state of Wisconsin, represented in senate and assembly, do enact as follows :*

SECTION 1. The qualified electors of the towns of Necedah, Lemonwier, Seven Mile Creek and village of Mauston, shall have power, at the annual meeting thereof, to vote to raise by tax such sum or sums of money <sup>\$500 may be raised in each town.</sup>
