

*claiming to have any interest in such public utility, by publication of such notice once a week for not less than three successive weeks in at least one newspaper of general circulation printed in the English language and published in the county in which such public utility is located, which publication shall be caused to be made by the municipality. Within a reasonable time, not exceeding one year, after the time fixed for such hearing in such notice the commission shall, by order, fix and determine and certify to the municipal council, \* \* \* to the public utility and to any bondholder, mortgagee, lienor or other creditor appearing upon such hearing, just compensation to be paid for the taking of the property of such public utility actually used and useful for the convenience of the public and all other terms and all conditions of sale and purchase which it shall ascertain to be reasonable. The compensation and other terms and the conditions of sale and purchase thus certified by the commission shall constitute the compensation and terms and conditions to be paid, followed, and observed in the purchase of such plant from such public utility. Upon the filing of such certificate with the clerk of such municipality the exclusive use of the property taken shall vest in such municipality.*

Section 1797m—83. Any public utility or the municipality or any bondholder, mortgagee, lienor or other creditor of the public utility, being dissatisfied with such order, may commence and prosecute an action in the circuit court to alter or amend such order or any part thereof, as provided in sections 1797m—64 to 1797m—73, inclusive, and said sections so far as applicable shall apply to such action.

SECTION 2. This act shall take effect and be in force from and after its passage and publication.

## CHAPTER 663.

AN ACT to correct errors in, and to amend certain sections of the statutes; to repeal expressly certain other sections of the statutes that have been either superseded or repealed by implication; and to exclude certain other sections from the statutes without affecting their validity as sections of the session laws.

*The people of the State of Wisconsin, represented in Senate and Assembly, do enact as follows:*

SECTION 1. Paragraph (a) of subsection 2 of section 11—12 the statutes is amended by striking out the following: “Sub-

section 1 of section 47 of the statutes of 1898, as amended by chapter 432, laws of 1905, is amended to read: 1."

SECTION 2. Subsection 4 of section 141 of the statutes is amended by striking out the word, "ten" and inserting in place thereof the word, "sixty;" and further by striking out the word, "September" and inserting in place thereof the word, "June."

SECTION 3. Subsection 11 of section 141 of the statutes is repealed.

Such reports shall be published with the next annual or biennial reports of the same officers, boards, or commissions, respectively, or of their successors.*

SECTION 503. Section 4601b of the statutes is amended by striking therefrom the words, "this act" and inserting in place thereof the words, "this section;" also by striking out the words, "the next preceding section" and inserting in lieu thereof the words, "section 4601a."

SECTION 504. Section 4601e of the statutes is amended by striking therefrom the words and figures, "of 1898 and laws amendatory thereof."

SECTION 505. Section 4601f of the statutes is amended by striking therefrom the words, "this act" and inserting in place thereof the word and figures, "section 4601e."

SECTION 506. Section 4601g and subsection 2 of section 4601h of the statutes are severally amended by striking from each the words, "this act" and inserting in each place thereof the words, "this section."

SECTION 507. Subsection 3 of section 4601h of the statutes is amended by striking therefrom the words, "this chapter" and inserting in place thereof the words, "this section."

SECTION 508. Section 4607b—2 of the statutes is amended by striking therefrom the words, "this act" and inserting in place thereof the words and figures, "sections 4607b—1 to 4607b—3, inclusive."

SECTION 509. Section 4607b—3 of the statutes is amended by striking therefrom the words, "this act" and inserting in place thereof the words and figures, "sections 4607b—1 and 4607b—2."

SECTION 510. Section 4607b—9 of the statutes is amended by striking therefrom the words, "this act" and inserting in place thereof the words and figures, "sections 4607b—4 to 4607b—9, inclusive."

SECTION 511. Section 4607d—2 of the statutes is amended by striking therefrom the words, "this act" and inserting in place thereof the word and figures, "section 4607d—1."

SECTION 512. Sections 4608n and 4608o of the statutes are repealed.

SECTION 513. Sections 4608p, 4608q, 4608r, 4608s, and 4608t of the statutes are severally amended by striking from each the words, "this act" and inserting in each place thereof the words and figures, "sections 4608p to 4608t, inclusive."

SECTION 514. Sections 4734a, 4734b and 4734c of the statutes are severally amended by striking from each the words, "this act" and inserting in each place thereof the words and figures, "section 4734a to 4734l, inclusive."

SECTION 515. Section 4734d of the statutes is amended by striking therefrom the word "hereunder" and inserting in place thereof the words and figures, "under sections 4734a to 4734l, inclusive."

SECTION 516. Section 4734f of the statutes is amended by striking therefrom the words and figure, "section 3 of this act" and inserting in place thereof the word and figures, "section 4734e."

SECTION 517. Section 4734k of the statutes is amended by striking therefrom the words, "of this act."

SECTION 518. Sections 4918—5, 4918—8 and 4918—9 of the statutes are severally amended by striking from each the words, "this act" and inserting in each place thereof the words and figures, "sections 4918—1 to 4918—10, inclusive."

SECTION 519. Subsection 5 of section 4947a of the statutes is amended by striking therefrom the words, "this act" and inserting in place thereof the words, "this section."

SECTION 520. Section 4960e—3 of the statutes is amended by striking therefrom the words, "this act" and inserting in place thereof the words and figures, "sections 4960e—1 to 4960e—7, inclusive."

SECTION 521. Subsection 1 of section 4966 of the statutes is amended by striking therefrom the words, "this act" and inserting in place thereof the words, "this section."

SECTION 522. The purposes of this act are to amend certain sections of the statutes by correcting errors therein, to repeal expressly certain sections of the statutes that have been either

superseded or repealed by implication, and to exclude certain sections from the statutes without affecting their validity as sections of the session laws, for convenience in consolidation and revision of the statutes; and the act shall be interpreted as accomplishing those purposes without effecting any repeals by implication or any substantive changes of law.

SECTION 523. This act shall take effect and be in force from and after its passage and publication.

## CHAPTER 664.

AN ACT to amend certain sections and chapters of the laws of 1911, by correcting errors therein and for convenience in consolidation and revision of the statutes.

*The people of the State of Wisconsin, represented in Senate and Assembly, do enact as follows:*

SECTION 1. Section 1 of chapter 12 of the laws of 1911 is numbered section 1797m—86m of the statutes.

SECTION 2. Section 1 of chapter 14 of the laws of 1911 is numbered section 1797m—74m of the statutes.

SECTION 3. Section 1 of chapter 28 of the laws of 1911 is amended by striking from section 1797—37m the words, "section 12, chapter 362 laws of 1905" and inserting in lieu thereof the words, "section 1797—12 of the statutes."

SECTION 4. Chapter 50 of the laws of 1911 is amended by striking from section 2394—2 the words, "the preceding section of this act" and inserting in lieu thereof the words, "section 2394—1."

Said chapter is further amended by striking from section 2394—3 the words, "as amended by chapter 254 of the laws of 1907"; also by striking therefrom the words, "the two preceding sections of this act" and inserting in lieu thereof the words, "sections 2394—1 and 2394—2" and by striking out the words, "as amended" and the words, "and amendatory acts" and by striking out the words, "the preceding sections of this act" and inserting in lieu thereof the words, "sections 2394—1 and 2394—2."

Said chapter is further amended by striking from subsection 1 of section 2394—4 the words, "this act" and inserting in lieu thereof the words, "sections 2394—1 to 2394—31, inclusive," and by striking out from the last paragraph of said section the words, "this act and acts amendatory thereof" and inserting in
