

(5.11) (1) * * * *Not later than the first Tuesday of August* before the September primary each county clerk shall prepare sample official ballots in substantially the annexed form which sample ballots shall be printed upon tinted or colored paper; and shall contain no blank indorsement or certificate. Said clerk shall place thereon, under the appropriate title of each office and party designation, the names of all candidates to be voted for in the precincts of his county. The names certified by the secretary of state shall be arranged in the order in which they are certified.

(5) * * * *Not later than the second Tuesday of August* before such primary the county clerk shall correct any errors or omissions in the ballot, cause the same to be printed and distributed as required by law in the case of ballots for the general election, except that the number of ballots to be furnished to each precinct shall * * * *not exceed* twice the number of votes cast thereat in the last preceding general election.

(6) The order in which the names of nonpartisan candidates shall be printed on the ballot at city primaries shall be determined by drawing lots by or under the supervision of the city clerk at his office, at twelve o'clock on the * * * *day* first succeeding the last day for filing such papers.

SECTION 2. This act shall take effect upon passage and publication.

CHAPTER 353.

AN ACT to renumber sections 925n—1 to 925n—14 of the statutes, created by chapter 75 of the laws of 1919 and place them in a new chapter of the statutes entitled "Chapter 64. City Manager Plan."

The people of the state of Wisconsin, represented in Senate and Assembly, do enact as follows:

SECTION 1. The fourteen sections of the statutes which were created by chapter 75 of the laws of 1919 shall be inserted in the statutes as sections of a new chapter to be numbered and entitled:

"CHAPTER 64. CITY MANAGER PLAN."

SECTION 2. The sections of the statutes created by said chapter 75 of the laws of 1919 are renumbered as follows:

Section 925n—1 is renumbered to be section 64.01.

Section 925n—2 is renumbered to be section 64.02.

Section 925n—3 is renumbered to be section 64.03.

Section 925n—4 is renumbered to be section 64.04.

Section 925n—5 is renumbered to be section 64.05.

Section 925n—6 is renumbered to be section 64.06.

Section 925n—7 is renumbered to be section 64.07.

Section 925n—8 is renumbered to be section 64.08.

Section 925n—9 is renumbered to be section 64.09.

Section 925n—10 is renumbered to be section 64.10.

Section 925n—11 is renumbered to be section 64.11.

Section 925n—12 is renumbered to be section 64.12.

Section 925n—13 is renumbered to be section 64.13.

Section 925n—14 is renumbered to be section 64.14.

SECTION 3. Each of the statutory sections so renumbered which contains the words and figures "sections 925n—1 to 925n—14 inclusive" is amended by striking out said words and figures, wherever they appear therein, and by inserting in lieu thereof at each such place the words "this chapter" except that the substitute for said words and figures at the second place where they appear in subsection 2 of section 925n—3 shall be the word and figures "chapter 64". Said sections are further amended by enclosing each of their respective subsection numbers in a parenthesis.

SECTION 4. Subsection 1 of section 925n—4 and section 925n—8 are further amended by striking from the body of each thereof the figures "925n—3" and by inserting in each place thereof the figures "64.03."

SECTION 5. Section 1 of chapter 110 of the laws of 1919 is amended by striking therefrom the figures "63" at every place therein where those figures appear and by inserting in lieu thereof at each of said places the figures "64"; also by adding at the end of said section the following matter, to wit:

"Chapter 63 is renumbered to be chapter 64p.

Chapter 64 is renumbered to be chapter 64pp."

And section 2 of said chapter 110 is amended by adding thereto the following matter: "And each section so renumbered which contains as a part of its text any figures heretofore designating one or more of the sections of chapter 51 is amended by striking out all such figures and by inserting in each place thereof the new number of the section designated by the figures stricken out."

SECTION 6. This act shall take effect upon passage and publication.
