CHAPTER 346.

AN ACT to amend subsection (2) of section 59.46 of the statutes, relating to the employment of clerks and stenographers in certain counties.

The people of the State of Wisconsin, represented in Senate and Assembly, do enact as follows:

SECTION 1. Subsection (2) of section 59.46 of the statutes is amended to read: (59.46) (2) The district attorney *in any county containing a city of the first, second or third class* may also appoint one or more clerks and one or more stenographers, the number and salary of whom is to be fixed by the board at any meeting thereof.

SECTION 2. This act shall take effect upon passage and publication.

CHAPTER 347.

AN ACT to amend section 60.07 of the statutes, relating to the time of holding town meetings.

The people of the State of Wisconsin, represented in Senate and Assembly, do enact as follows:

SECTION 1. Section 60.07 of the statutes is amended to read: 60.07 There shall be an annual town meeting in each town on the first Tuesday of April at which all business shall be transacted which is by law required or permitted to be transacted at such meeting; and no notice of holding any annual town meeting

need be given. *The hour for holding succeeding annual town meetings may be fixed at any such meeting.*

SECTION 2. This act shall take effect upon passage and publication.

CHAPTER 348.

AN ACT to grant certain reclaimed lands lying along the shores of Green Bay on the east frontage of the city of Marinette for public park purposes.

The people of the State of Wisconsin, represented in Senate and Assembly, do enact as follows:

SECTION 1. All of the right, title and interest in and to the following described land is hereby ceded, granted, quitclaimed and conveyed for public park purposes to the city of Marinette in fee, to-wit:

All that tract of land formed by accretion and reliction lying and being south of the north line, extended or produced easterly, of block fifty (50) of the Menominee River Lumber Company's First Addition to Menekaune, Wisconsin, section "A", and lying and being east of the west line, extended or produced southerly, of block forty-eight (48) of the Menominee River Lumber Company's First Addition to Menekaune, Wisconsin, section "A"; said tract of land lying and being adjacent to the southeast boundary of fractional section nine (9), township thirty (30) north, range twenty-four (24) east, in the county of Marinette.

SECTION 2. The commissioners of public lands are hereby authorized, empowered and directed to and shall execute and deliver to the said city of Marinette a patent for said tract of land hereinbefore specifically described in accordance with the provisions of this act.

SECTION 3. This act shall take effect upon passage and publication.
