CHAPTER 291.

AN ACT to create 20.02 (10) of the statutes, relating to the administration of selective service activities to meet the particular needs of Wisconsin, and making an appropriation.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

20.02 (10) of the statutes is created to read:

20.02 (10) **SELECTIVE SERVICE ADMINISTRATION.**

(a) Annually, beginning July 1, 1943, \$1,000 for meeting necessary expenses in connection with the administration of the selective service system in Wisconsin.

(b) For the fiscal year ending June 30, 1943, \$750 for meeting necessary expenses in connection with the administration of the selective service system in this state and for the payment of such expenses or the reimbursement to any person having made any payment for such expenses prior to the effective date of this paragraph.

CHAPTER 292.

AN ACT to amend 59.99 (2) of the statutes, relating to the board of adjustment.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

59.99 (2) of the statutes is amended to read:

59.99 (2) The board of adjustment shall consist of 3 members, who shall be appointed *or elected* as herein provided. The chairman of the county board shall appoint, with the approval of the county board, 3 members for terms of 1, 2 and 3 years, respectively, dating from July 1, 1927; *provided, that in counties having a population of 500,000 or more such members shall be elected for like terms by the county board.* Successors shall be appointed *or elected* in like manner at the expiration of each term and their terms of office shall be 3 years in all cases, be-

ginning July 1 in the year in which they are appointed *or elected* and until their successors are appointed *or elected*. The members of the board shall all reside within the county and outside of the limits of incorporated cities and villages; provided, however, that no 2 members shall reside in the same town. The board shall choose its own chairman. Office room shall be provided by the county board, and the actual and necessary expenses incurred by the board in the performance of its duties shall be paid and allowed as in cases of other claims against the county. The county board may likewise compensate the members of said board and such assistants as may be authorized by said county board. Vacancies shall be filled for the unexpired term of any member whose term becomes vacant.

CHAPTER 293.

AN ACT relating to the appropriation of certain accrued balances for the state office building, and making an appropriation.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

All construction or equipment balances accruing under chapter 385, laws of 1931; chapter 120, laws of 1937 and chapter 54, laws of 1939, are reappropriated as a nonlapsible appropriation to the state office building commission to be applied toward the completion and equipment of the state office building project in accordance with the original design and intent. The used portion of this appropriation, together with the used portion of any subsequent appropriation for the completion and equipment of said project, shall be amortized to reimburse the state insurance fund in a period of not to exceed 20 years, with simple interest of 3 per cent per annum to begin from dates of withdrawals. Said amortization shall begin when the project is completed, occupied and income-producing.
