CHAPTER 259, Laws of 1971

AN ACT to amend 20.445 (9) (x) 3 and 108.161 (4) (d); and to repeal and recreate 20.445 (9) (x) 8 of the statutes, and to create section 518 (11) of chapter 125, laws of 1971, relating to using certain money credited under federal law for employment security building projects, and making appropriations.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

SECTION 1. 20.445 (9) (x) 3 of the statutes is amended to read:

20.445 (9) (x) 3. The amount obligated pursuant to this subsection during any fiscal year shall not exceed the aggregate of all amounts credited under s. 108.161 (1), including amounts credited pursuant to s. 108.161 (8), within that fiscal year and the ~~14~~ 24 preceding fiscal years, reduced by the sum of any moneys obligated and charged against any of the amounts thus credited within those ~~15~~ 25 years.

SECTION 2. 20.445 (9) (x) 8 of the statutes is repealed and recreated to read:

20.445 (9) (x) 8. There is appropriated, from the unemployment reserve fund's employment security administrative financing account created by s. 108.161, to the administration fund created by s. 108.20, for use on employment security building projects in accordance with those sections:

a. On the effective date of this subdivision (1971), any amounts credited to that employment security administrative financing account which are then unobligated and available for obligation pursuant to s. 108.161.

b. From the effective date of this subdivision (1971) to June 30, 1972, various amounts (on the dates when credited to that account) totaling \$65,700, but not to exceed the total amount credited to that account and available for obligation through June 30, 1972.

c. From July 1, 1972, to June 30, 1973, various amounts (on the dates when credited to that account) totaling \$194,500, but not to exceed the total amount credited to that account within that fiscal year.

d. From July 1, 1973, to June 30, 1974, various amounts (on the dates when credited to that account) totaling \$201,000, but not to exceed the total amount credited to that account within that fiscal year and within 2 years after the effective date of this act (1971).

SECTION 3. 108.161 (4) (d) of the statutes is amended to read:

108.161 (4) (d) Limiting the total amount which may be so obligated during any fiscal year to the aggregate of all amounts credited under sub. (1), including amounts credited pursuant to sub. (8), within that year and the ~~14~~ 24 preceding fiscal years, reduced by the sum of any moneys obligated and charged against any of the amounts thus credited within those ~~15~~ 25 years.

SECTION 3m. Section 518 (11) of chapter 125, laws of 1971, is created to read:

(Chapter 125, laws of 1971) Section 518 (11) One employment security building may be constructed in the city of Fond du Lac at a total cost of \$350,000. Financing for the project shall be wholly from federal funds.

SECTION 4. The amounts appropriated by this act are available for obligation solely within the 2 years beginning on its date of enactment.
