**“My Beautiful State—Wisconsin”**

If someone came up to me and asked me, “What is the best state in the union of the United States of America?”, I would probably say Wisconsin.

To me the name, Wisconsin, stands for many things. They are:

W—is for the water. Wisconsin has a lot of clear, blue water left in the northern half of the state. When I think of the clear, blue water, I think of it as being cool and also refreshing.

I—is for the Indians. They were the very first ones to own and explore this vast land.

S—is for the soil. With this dark, rich soil we grow all kinds of crops.

C—is for the colleges. The colleges that we have here in our state help educate us more so that we are ready to take higher and more important jobs.

O—is for the old times. These times brought about a lot of changes.

N—is for our natural resources. These include what most of our state was once and once had—timberland and the minerals deep in the soil.

S—is for the seasons. I think that Wisconsin has the most beautiful seasons of the year. There are not enough words to describe the wintertime in Wisconsin nor the enjoyable beauty of the other seasons.

I—is for our importance. Here in Wisconsin we have many things which make us important. We have our beautiful wildlife, our dairylands, mills and many plants, endless miles of timber, and also our trout and other fish. We can also be proud of John Brockington for giving the Green Bay Packers a good year. These and many other things we can be proud of.

N—is for the new and modern things we have. One of which we built two nuclear power plants. With this power, we can do many things that we could not do before.

The nickname of our state is the “Badger State.” This name originated from the early prospectors. The prospectors

lacked time and suitable tools with which to build homes so they then lived in caves in the hillsides, like the badgers.

Our state song is "On Wisconsin." The words to this song were written by J. S. Hubbard and Charles D. Rosa in 1913. (This fact was stated in the book "Wisconsin and its Government." It is prepared for the Badger Boys State. It is a 1968-1969 edition. In the 1972 World Book Encyclopedia it states that the words to the song "On Wisconsin" were written by Carl Beck, and the music was written by William T. Purdy.) The song, "On Wisconsin," was adopted as the official state song by the Wisconsin legislature in 1959.

Our state motto is "Forward." Helen Mears created a statue and called it "Miss Forward." She did not get credit for the statue when it was put on the new capitol building at Madison, Wisconsin.

Some important animals we have are as follows:

The badger is our state animal. The white-tailed deer is known as our wildlife animal. Our state bird is the robin. Our state fish is the muskellunge.

We also have some important plants. The wood violet is known as our state flower. Our state tree is the sugar maple.

The name Wisconsin used to be spelled "Outsconsin" (which is the French version of an Indian word meaning "gathering of the waters." Then the Yankee settlers changed the name to "Wiskonsan." The present spelling, "Wisconsin," was created by an act of Congress.

The first white man that visited Wisconsin was Jean Nicolet, in the year of 1634. Jean Nicolet is credited with being the first white man to set foot on Wisconsin soil.

Jean Nicolet had been commissioned by Samuel de Champlain to explore the region west of Lake Huron and to instruct the Indians in the benefits of religion and the fur trade. In the summer of 1634 he landed near Green Bay and went up the Fox River as far as the present city of Berlin. Altogether Jean Nicolet traveled over two thousand miles.

There were many more explorers and expeditions that marked off the history of Wisconsin. All these facts are
