Dear Mr. Bolle:

1977 Assembly Resolution No. 17 requests an opinion of the Attorney General on the constitutionality of the \$100,000 limitation on recovery in civil actions against state officers or employees under sec. 895.45, Stats.

This is to advise that there are several legal actions pending in circuit court testing this very issue. Therefore, it would be inappropriate and possibly unethical for the Attorney General to issue an opinion as requested by Assembly Resolution No. 17 since this office is involved in this litigation defending the constitutionality of the limitation. Therefore, we must respectfully decline to respond.

Presumably, a final judgment in one of the pending cases will provide the answer. Unfortunately, a final judgment probably will not be forthcoming until the matter is resolved by the supreme

court and given its current backlog, I do not anticipate a final answer for several years.
