From: State of Arizona Thirty-third Legislature

House Concurrent Memorial 2003

Urging an amendment to the Constitution of the United States to require that federal appropriations not exceed estimated federal revenues except in an emergency.

To the President and the Congress of the United States of America:

Your memorialist respectfully represents:

Whereas, with each passing year this nation becomes more deeply in debt as its expenditures grossly and repeatedly exceed available revenues, so that the public debt now exceeds hundreds of billions of dollars; and

Whereas, attempts to limit spending, including impoundment of funds by the President of the United States, have resulted in strenuous objections that the responsibility for appropriations is the constitutional duty of the Congress; and

Whereas, the annual federal budget repeatedly demonstrates an unwillingness or inability of both the legislative and executive branches of the federal government to curtail spending to conform to available revenues; and

Whereas, unified budgets do not reflect actual spending because of the exclusion of special outlays which are not included in the budget nor subject to the legal public debt limit; and

Whereas, knowledgeable planning, fiscal prudence and plain good sense require that the budget reflect all federal spending and be in balance; and

Whereas, fiscal irresponsibility at the federal level, with the inflation which results from this policy, is the greatest threat which faces our nation; and

Whereas, constitutional restraint is necessary to bring the fiscal disciplines needed to reverse this trend; and

Whereas, under article V of the Constitution of the United States, amendments to the constitution may be proposed by the Congress whenever two-thirds of both houses deem it necessary or on the application of the legislatures of two-thirds of the states the Congress shall call a constitutional convention for the purpose of proposing amendments.

Wherefore, your memorialist, the House of Representatives of the State of Arizona, the Senate concurring, prays:

1. That the Congress of the United States prepare and submit to the several states an amendment to the constitution requiring, in the absence of a national emergency, that the total of all federal appropriations made by the Congress for any fiscal year not exceed the total of the estimated federal revenues, excluding any revenues derived from borrowing, for that fiscal year.

2. That, in the alternative, the Congress of the United States call a constitutional convention to prepare and submit such an amendment to the constitution.

3. That this application continue in effect until the will of the Legislature of Arizona to the contrary is communicated to the Congress of the United States.

4. That the Secretary of State of Arizona transmit certified copies of this memorial to the President of the United States, the President of the United States Senate, the Speaker of the United States House of Representatives, to each member of the Arizona delegation to the United States Congress and to the presiding officers of each house of the legislature of each of the other states of the union with the request that it be circulated among leaders in the executive and legislative branches of the state governments.

Resolution 93

Relative to requesting the several states of the United States to ratify the 27th Amendment to the United States Constitution to guarantee the equal rights of all persons regardless of sex.

Be it resolved by the legislature of the Territory of Guam:

Whereas, the unincorporated territory of Guam is a territory of the United States and its people are subject to certain benefits, privileges, powers, rights and duties deriving from the Constitution of the United States; and

Whereas, the 27th Amendment, which has been proposed, would guarantee the equal rights of all persons regardless of sex and said amendment would be applicable to all persons, both those residents within the United States proper and those residents within the outlying territories and possessions; and

Whereas, the Legislature of Guam is firmly committed to the principle embodied in the proposed said amendment, namely that equality of rights under the law shall not be denied or abridged by the Federal Government nor any state on account of sex; now, therefore, be it

Resolved, that the Guam Legislature does hereby commend the legislatures of those states which have already ratified the proposed said amendment and does hereby exhort and encourage the remaining states to speedily ratify the proposed said amendment; and be it further

Resolved, that the Speaker certify to and the Legislative Secretary attest the adoption hereof and that copies of the same be thereafter transmitted to each of the several state legislatures and to the Governor of Guam.

House Joint Resolution 25

A Joint Resolution of the Senate and the House of Representatives of the State of Montana urging Congress to review OSHA.

Whereas, the procedures outlined by OSHA for its administrators are without authorization by the Congress; and

Whereas, better, less harmful methods of administering the purposes of the act are readily available; and

Whereas, Title 29, USC Chapter 15, Section 651, is an unconstitutional delegation by the Congress to the Secretary of Labor, without setting out guidelines or delineating limits upon the administrator and therefore is void; and

Whereas, Section 659 of the act gives an unfair advantage to the Federal Government in severely limiting the time for an appeal and foreclosing the grounds for additional remedies; and

Whereas, OSHA threatens the existence of business enterprises because if a firm lacks the resources to institute the changes required by OSHA, there is no alternative but to close down; and

Whereas, undue delegation of authority is granted to the OSHA inspectors; and

Whereas, regulations under OSHA contained in more than 800 pages with more than 4,400 sections are complex, the language is convoluted beyond recognition except by a scientist or lawyer, and businessmen who have no legal or scientific training are unable to understand OSHA regulations; and

Whereas, a Cornell Law School Professor has said perhaps the statute should be declared void for rampant complexity because citizens must understand what they are not permitted to do; and

Whereas, in the first 33 businesses obtaining small business loans for the purpose of OSHA compliance averaged loans of \$200,000 apiece, so it is obvious that OSHA regulations are remaking the daily practices of the business world in a major way; and

Whereas, according to Robert Stewart Smith, formerly in charge of safety and health evaluation for the Department of Labor, OSHA has done nothing to improve the industrial accident record and injury rates were higher, not lower, in industries with good compliance ratings; and

Whereas, the OSHA normal practice of fining an employer, even if a worker willfully violates a rule, is grossly unfair to businessmen.

Now, therefore, be it resolved by the Senate and the House of Representatives of the State of Montana:

That Congress is urged to review the Occupational Safety and Health Act of 1970 to eliminate those practices and procedures which violate the Constitution of the United States.

Be it further resolved, that the Secretary of State send copies of this resolution to the Assistant Secretary for Occupational Safety and Health, Morton Corn; the Montana Congressional Delegation; and to each of the other State Legislatures; and to the Montana Attorney General.

Senate Joint Resolution 3

Requesting the Congress of the United States to submit to the state legislatures an amendment to the United States Constitution which would limit federal appropriations for any fiscal year to federal revenues estimated for that year, except during national emergencies.

Whereas, The national debt now amounts to hundreds of billions of dollars and is increasing enormously each year as federal expenditures grossly exceed federal revenues; and

Whereas, Payment of the increased interest on this ever-expanding debt imposes a tremendous burden on the taxpayers of this country; and

Whereas, Continuous deficit financing by the Federal Government supports inflationary conditions which adversely affect the national economy and all Americans, particularly those persons with fixed or low incomes; and

Whereas, Constantly increasing use of deficit financing has enabled the Federal Government to allocate considerable sums to programs which in many instances have proved to be wasteful and nonbeneficial to the public; and

Whereas, Limiting federal expenditures in each fiscal year to revenues available in that year, except during national emergencies, will result in greater selectivity of federal programs for the benefit of the public; and

Whereas, The annual federal budgets continually reflect the unwillingness or inability of both the legislative and executive branches of the Federal Government to balance the budget and demonstrate the necessity for a constitutional restraint upon deficit financing; and

Whereas, Under article V of the Constitution of the United States, the Congress may propose amendments to the federal Constitution whenever two-thirds of both houses deem it necessary; now, therefore, be it

Resolved by the Senate and Assembly of the State of Nevada, jointly, That this legislature respectfully requests the Congress of the United States to submit to the legislatures of the several states an amendment to the United States Constitution which would require that, in the absence of a national emergency, the total of the appropriations made by the Congress for each fiscal year may not exceed the total of the estimated federal revenues for that year; and be it further

Resolved, That the legislature of the State of Nevada proposes that the legislatures of each of the several states request the Congress to submit the constitutional amendment proposed in this resolution; and be it further

Resolved, That a copy of this resolution be immediately transmitted by the legislative counsel to the President of the Senate and the Speaker of the House of Representatives of the United States, to each member of the Nevada congressional delegation and to the presiding officer of each house of the legislatures of the several states; and be it further

Resolved, That this resolution shall become effective upon passage and approval.

Resolutions requesting the congress of the United States to call a convention for the purpose of proposing an amendment to the constitution of the United States protecting the right to life of all human beings during every stage of biological development.

Resolved, That the General Court of the Commonwealth of Massachusetts respectfully petitions the Congress of the United States pursuant to Article V of the United States Constitution to call a convention for the purpose of proposing the following article as an amendment to the Constitution of the United States:

Section 1. With respect to the right to life, the word person as used in this article and in the Fifth and Fourteenth Articles of Amendment to this Constitution applies to all human beings irrespective of age, health, function, or condition of dependency, including their unborn offspring at every stage of their biological development.

Section 2. No unborn person shall be deprived of life by any person, provided, however, that nothing in this article shall prohibit a law permitting only those medical procedures required to prevent the death of the mother.

• Section 3. The Congress and the several states shall have the power to enforce this article by appropriate legislation; and be it further

Resolved, That a duly attested copy of these resolutions be immediately transmitted by the Clerk of the House of Representatives to the Secretary of the Senate of the United States, the Clerk of the House of Representatives of the United States, to each member of Congress from this Commonwealth, and to each house of each state legislature in the United States.
