#### GOVERNOR'S VETO MESSAGES

September 14, 1977

To the Honorable, the Assembly:

I have approved Assembly Bill 510 as Chapter 87, Laws of 1977, and deposited it in the office of the Secretary of State.

Assembly Bill 510 authorizes the Department of Agriculture, Trade and Consumer Protection to license persons engaged in activities intended to modify weather and to issue permits. The bill creates a council on weather modification to advise the Department concerning criteria for issuing licenses. AB 510 grants all regulatory authority in this area to the Department of Agriculture, Trade and Consumer Protection; it repeals provisions of current law which vest this power with the Public Service Commission.

AB 510 serves the public interest because it establishes a regulatory mechanism which will provide a greater degree of public protection than is possible under the current law. However, I am concerned that the bill does not adequately provide for sufficient public involvement in the permit-granting process. current language provides that the Department "may hold a public hearing for the purpose of obtaining information from the public concerning the effects of issuing or refusing to issue the permit." I have item vetoed the word "may" in order to require the Department to hold public hearings. A number of persons may be affected in very different ways by a specific weather modification project. For this reason I believe that all concerned persons must be guaranteed the opportunity to express their opinions at a public hearing. The expense and inconvenience which public hearings may pose for the Department are not sufficient to justify risking a loss of public involvement in this important area.

For these reasons, I urge the legislature to sustain this item veto.
