Upon the direction of the Committee on Assembly Organization I am submitting a request for your opinion on the constitutionality of expending state funds by providing money to nonprofit organizations for developing waterfowl propagation areas within Canada under section 29.102 (2) (b) of the statutes as created by this act (Assembly Bill 894), no money may be expended until after the opinion of the Attorney General has been issued. You have requested an informal opinion concerning whether sec. 13.565 (1), Stats., applies to the proposed Wis. Adm. Code section AG 30, entitled "Sanitary and Quality Standards for Milk." The content of your letter suggests that your specific question is: **Whether the regulation of animal waste treatment in any form and**

in any portion of an administrative scheme brings the entire scheme or, at least, that specific portion of the scheme which relates to animal waste treatment, under sec. 13.565 (1), Stats.

I am of the opinion that in this particular case sec. 13.565 (1), Stats., does not affect proposed AG 30, in whole or in part. The reasons for my conclusions are set forth below.

Section 13.565 (1), Stats., provides as follows:

"Prior to the establishment of any rules relating to animal waste treatment, the state agency proposing the rules shall submit the rules to the senate and assembly committees on agriculture. A public hearing shall be held before the committees to review the proposed rules. The rules shall enter into effect only upon approval as a joint resolution by each house of the legislature." (Emphasis added.)

Two things which pertain to your question emerge from the statutory language. First, the Legislature intends apparently that the review and consent aspects of sec. 13.565 (1), Stats., be exercised prior to the establishment of rules. Second, operation of sec. 13.565 (1) is to prevent a proposed rule on the subject matter from going into force before a joint resolution is passed by each house.

The provisions in proposed AG 30 which affect animal waste treatment or facilities associated with that kind of operation are not new rules. These provisions appear in the presently existing AG 30; they have only been renumbered and rearranged in proposed AG 30. Only the first sentence of proposed AG 30.08 (1) (b) represents any change of language, and that is merely a paraphrase of AG 30.03 (6). These provisions were in force at least by 1968, prior to the effective date of sec. 13.565 (1). (See Wis. Adm. Code section AG 30, p. 88 and Wis. Stats. Ann. vol. 3, p. 73 (1972).) When an agency proposes reorganizing and adding to the code provisions which are merely a rearrangement of existing rules, such a proposal is not the establishment of rules within the meaning of sec. 13.565, Stats.

If the respective committees would attempt to act on these proposals pursuant to sec. 13.565 (1), and fail to approve, they would in effect be suspending already established rules. The effect of such an action would be at least temporary repeal of an administrative rule by a committee of the Legislature, a function

clearly outside of the legislatively delegated powers of sec. 13.565 (1), Stats.

I might add parenthetically that there is a possible conflict between secs. 13.56 and 13.565 (1), Stats. With respect to rules which are yet to be established, a clear legislative enactment could eliminate any confusion concerning the Legislature's intent with respect to simultaneous or separate effect of these two sections. Such an enactment might also address itself to the definition of what constitutes "any rules relating to animal waste treatment."
