Representative Shabaz stated that the motion was also not proper under Assembly Rule 69 because there had been no significant intervening business.

The speaker ruled not well taken the point of order raised under Assembly Rule 65 because the language "shall not be allowed again on the same day and at the same stage in the consideration of that proposal" required both conditions to be met. Because the motion for nonconcurrence in senate amendment 1 had been made and lost on a previous day, the motion was ruled proper.
