GOVERNOR'S VETO MESSAGES

March 8, 1978

To the Honorable Members of the Assembly:

I am returning **Assembly Bill 321** without my approval.

As enacted, the bill permits the state funding of abortions necessitated by rape or incest or to save the life of the mother, but it does not provide state assistance for abortions which are needed to prevent grave physiological injury.

It is my belief that the state has an obligation to protect poor women against grave physiological injury. Had the bill passed in a form which permitted the state to assist them in such dire circumstances, it would have had my approval.

I continue to be personally opposed to abortion, but society cannot tolerate a situation in which a woman's ability to protect her health is determined by her ability to pay. Our constitution was not designed to accommodate such a double standard.

Proponents of AB 321 had an opportunity to enact reasonable, humane legislation on state funding of abortions. They chose instead to pass legislation so restrictive and so different from federal law that I am left with no alternative than to honor my pledge to veto the bill.
