A Proclamation

I, MARTIN J. Obtaining advice and consent to all gubernatorial nominations for appointment then pending.

A Proclamation

I, MARTIN J. SCHREIBER, Acting Governor of the State of Wisconsin, under and by virtue of Section 11 of Article IV of the Constitution of Wisconsin, which provides that the Governor shall have power to convene the Legislature on extraordinary occasions, do issue this, my proclamation expanding the purposes for which the Legislature of the State shall convene at the seat of government, on the twentieth day of December, A.D., 1978, at 10 o'clock a.m., to include, along with the consideration of the legislative business specified in my proclamation of the eleventh day of December, A.D., 1978, the following additional subjects of legislative business, to wit:

Changes in the election laws to permit special elections to be called concurrently with the 1979 spring primary and election to fill anticipated vacancies in the Senate under certain circumstances.
