Dear Mr. Speaker:

The special subcommittee on Manure Handling has been appointed from the Agriculture and Nutrition Committee. This committee will consist of Gervase Hephner, Chairman, Lary Swoboda, Donald Hasenohrl, Patricia Smith, Joseph Tregoning and John Merkt.

The subcommittee will consider the following issues:

1) The economic impact of the proposed new waste handling rules on the 76,000 livestock owners in the state.

2) The impact of the proposed rules on the entire economy of the state.

3) The effect of the rules on other agricultural practices, such as soil erosion caused by a switch from livestock to row cropping.

4) The effect of a possible shift from animal waste to commercial fertilizers.

5) Other short- and long-term results.

The subcommittee will have three hearings in the state: one in the Northeast; one in the Northwest and one in Madison.

The Public Intervenor has presented the DNR with an eighteen page request to draft rules dealing with animal waste and its effect on groundwater and pollution of surface waters of the state.

It is important that a subcommittee examine these proposals and their effects on dairy and beef products in the state.
