I recently asked the Legislative Reference Bureau and Legislative Fiscal Bureau to identify any of the pending partial vetoes to Chapter 20, Laws of 1981, which have been, in effect, mooted out through subsequent legislative action on the same subject.

They reported to me that the following items have since been resolved:

Item I-CI--Soil and Water Conservation District Aids. The Chapter 20 item eliminated \$464,600 GPR of aid funding in 1981-82. Chapter 93 provisions included \$464,600 GPR of aid funding in 1981-82.

Item I-D--Minimum Farmland Tax Credit. The Chapter 20 item veto deleted a 10% minimum farmland tax credit. Chapter 93 provided for a minimum farmland tax credit.

Item II-A.5--Distribution of Aid Payments and Credits. The Chapter 20 item veto pushed certain aid costs into the next biennium. The item was amended by Chapter 93 but again partially vetoed. This partial veto to Chapter 93 is pending.

Item III-A--Reimbursements to Counties (Probation and Parole Funds). The Chapter 20 item veto deleted statutory authorization for H & SS to make a per diem reimbursement for certain felons held in county jails. Chapter 93 deleted the funding provided to H & SS by Chapter 20 to pay these costs.

Item IV-H--Special Adjustment Aid. The Chapter 20 item veto deleted funding for special adjustment aids. The item was dealt with in Chapter 93 but partially vetoed. The Chapter 93 item veto is pending.

Item IX-A--Medicaid Co-payment. The Chapter 20 item veto dealt with a conflict in the bill relating to co-payments for mandated medical assistance services. This item was dealt with in Chapter 93.

Item IX-B--Medicaid Co-payment for Hospitalized Patients. The Chapter 20 item veto created a requirement that hospitalized patients pay a co-payment on services which are

optional under medical assistance. This item was dealt with in Chapter 93.

Item XI-A--AFDC Child-only Payment. The Chapter 20 item veto clarified that the reduction in AFDC payments to groups which included only children did not apply to groups in which there is a caretaker under age 18. This item was dealt with in Chapter 93.

Item XI-C--Community Aids--Applied Receipts. The Chapter 20 item veto affected a portion of the applied receipts community aids appropriation. Chapter 93 eliminated the applied receipts appropriation and established two separate appropriations in its place.

Item XI-F--Displaced Homemakers. The Chapter 20 item veto deleted funding and provisions for a displaced homemakers program in H & SS. Chapter 93 provided funding and created a displaced homemakers program in the VTAE system.

Item XI-J--Earmarking of Federal Child Welfare Funds. The Chapter 20 item veto deleted the earmarking of specified amounts of anticipated federal receipts for use only on start-up costs of day care programs and runaway services. Chapter 93 provided for utilization of these amounts as increased funding for block grants to county social services departments.

Item XI-P--Shelter Care. The Chapter 20 item veto deleted a requirement that shelter care funds folded into the base allocation for county social services aid be expended for shelter care only. This item was dealt with in Chapter 93.

Item XIV-C--Elderly and Handicapped Aids. The Chapter 20 item veto deleted the establishment of trip-purpose priorities in distribution of elderly and handicapped transportation county assistance aids. This item was dealt with in Chapter 93.
