after layoff, to a position with a lower pay range, cumulative pay adjustments for certain nonrepresented state classified employes, a salary freeze for certain state employes, work hour and pay reductions for nonrepresented state employes, work-related programs for recipients of aid to families with dependent children, the expenditure of federal child welfare funds, making permanent the 2nd opinion program in medical assistance, kidney disease aids, the reimbursement rates for handicapped education special transportation and health treatment aidable costs, decreasing the primary guaranteed valuation for 1982-83 school aids and delaying part of the June 1982 aid payment until July 1982, the renewable energy resource system incentive program, granting rule-making authority, providing penalties and decreasing and making appropriations.

The report contains the results of a Department of Natural Resources study to determine the effects of restricting the use of phosphates in laundry detergents including the impact of phosphorus in surface waters and wastewater treatment plants.
