"In 1893, the world's leading and most respected medical authorities agreed that to penetrate the maze of blood vessels and nerves surrounding the heart was to invite sudden death. In fact, surgery inside the human body was still in its infancy.

Dr. Daniel Hale Williams, a young Black physician, was not discouraged by leading opinions when a patient with a puncture in his heart was admitted to surgery. Dr. Williams made the appropriate incision and grasped the fluttering organ with his forceps. With skilled hands, he proceeded to stitch the tissue together. The young patient survived to a ripe old age.

Dr. Williams won national prominence as the first surgeon to operate successfully on the human heart. His success was publicized in the leading medical journals.

Dr. Williams became a leading authority on female cancers and birth deliveries in tumorous mothers. He was also one of the earliest physicians to successfully repair ruptured spleens.

Dr. Williams became a member of the American College of Surgeons in 1913; the only Black out of hundreds of surgeons. As a leader of the Chicago Black community, Dr. Williams organized Provident Hospital, the first Black-run hospital in American history. Provident Hospital trained the country's first Black nurses. He also helped organize 40 other Black hospitals in 20 states.

Dr. Daniel Hale Williams was truly an outstanding American. His contributions to American society were far-reaching and beneficial to the growth of this country.

I commend Dr. Williams for the contributions he made and ask that his contributions be acknowledged by this body."
