LaFollette, 450 U.S. 107 (1981), and the failure of the Democratic leaders in the state of Wisconsin in their recent appeal to the National Democratic Committee for an exemption from the mandates of a closed primary, means that it is necessary for the Legislature to develop alternatives that respond to these recent developments.

I am appointing Representative Jeff Neubauer as the chair of the subcommittee. He will be primarily responsible for dealing with the various interested parties in the development of legislative proposals.

I am also appointing to the subcommittee Representative Marcia Coggs, Representative Barbara Ulichny and Representative Randall Radtke.
