A Proclamation

- I, Anthony S. Earl, Governor of the State of Wisconsin, pursuant to Section Eleven of Article IV and Section Four of Article V of the Constitution of Wisconsin, do hereby require the convening of a special session of the Legislature to take place at the Capitol in the City of Madison on the twelfth day of April, A.D., 1983, at 10:00 a.m., solely for the purpose of considering and acting upon the following specific legislative business relating to unemployment compensation, to wit:
 - 1. To revise laws relating to unemployment compensation.
 - 2. To grant rule-making authority.
 - 3. To provide penalties.
 - 4. To make appropriations.
