**EXECUTIVE COMMUNICATIONS**

*Executive Order Number 45*

I, Anthony S. Earl, Governor of the State of Wisconsin, pursuant to Section 11 of Article IV and Section 4 of Article V of the Constitution of Wisconsin, do hereby require the convening of a special session of the Legislature at the Capitol in Madison, beginning on February 2, 1984 at 9:30 a.m. solely to consider and act upon the following specific legislative business:

1. Altering the schedules for payment of Wisconsin state property tax relief and handicapped education, transportation, and general equalization aids to school districts.
2. Reducing the corporate and individual surtaxes for taxable year 1984 from 10% to 2.5%.

In testimony whereof, I have set my hand and caused the Great Seal of the State of Wisconsin to be affixed at the Capitol in Madison this day, January 31, 1984.
