I, along with Representative Jeannette Bell, will co-chair a subcommittee within Children and Human Services named the Adolescent Pregnancy Prevention Subcommittee. Our five person subcommittee will be rounded out with the participation of John Robinson, DuWayne Johnsrud and Margaret Lewis.

The purpose of the subcommittee will be to examine the problem of adolescent pregnancy in Wisconsin and recommend legislative remedies to the full committee. We anticipate visiting prevention programs throughout the state. Additionally, there is a prevention program in St. Paul, Minnesota, that I would like subcommittee members to visit. I am providing you with information on the program. My staff is ready to make arrangements for the trip once we ready the preliminary go-ahead. I hope to send a detailed memo to you regarding the subcommittee. I hope you will find the St. Paul program worthy of a visit by the subcommittee.

This is to inform you that I have established a Criminal Justice and Public Safety Subcommittee on the Revision of the Crime of Threat to Injure.

Representative Thomas Barrett will serve as chairperson, with Representatives Rebecca Young and Gary Schmidt as the remaining committee members.

The Subcommittee is directed to review and recommend changes in present s. 943.30, Stats., Threats to Injure or Accuse of Crime, which will improve the enforceability of the statute and eliminate the necessity of special crimes, such as those proposed in the Biennial Budget
