Dear Speaker Loftus:

Pursuant to Assembly Rule 11 (2), I am appointing a subcommittee of the Committee on Agriculture. The

subcommittee, which will bear the title of "Subcommittee on Rural Priorities," will be chaired by Representative David Clarenbach; the other members are Representatives John Volk and Joseph Tregoning.

The Subcommittee will focus its attention on developing comprehensive legislative proposals to address those problems of the agricultural sector and rural Wisconsin which the state is capable of resolving. Rather than the usual piece-meal, short-term approach which characterizes most agricultural legislation, the Subcommittee will be looking at longer-term solutions in, among others, the areas of taxation, availability of adequate financing, preservation of the rural infrastructure and ways of helping agriculture to become, once again, a profitable endeavor.

I have asked the Subcommittee to attempt to have legislation ready for consideration in Floorperiod V.
