Dear Mr. Schneider and Ms. Duren:

The State Elections Board is required to certify to county clerks all referendum questions to be submitted to the electors at the spring election on Tuesday, April 1, 1986. In order for the Elections Board staff to prepare the certification, it is necessary for us to have in our possession, no later than February 18, 1986, a certified copy of any resolution directing that a referendum be submitted to the electors at the 1986 Spring Election, along with an explanatory statement prepared by the attorney general under the provisions of s. 10.02 (2) (c), Wis. Stats.

Legislators seeking to secure the passage of a resolution which would direct the submission of a referendum question to the electors at the April 1, 1986 election, are encouraged to consult with the attorney general's office to develop the explanatory statement that must accompany the publication of the referendum notice by the county clerk. County clerks and the Elections Board need the intervening two week period between February 18, 1986 and March 4, 1986, to arrange for publication in the appropriate newspapers and for printing ballots. In addition, sufficient copies must be made of the published notice which includes the explanatory statement so that copies may be posted in all polling places at the April 1, 1986 election.

Thank you for your time and attention to this matter. Please include this letter in the senate and assembly journals. If any legislators have questions they are encouraged to contact the Elections Board staff.
