Under 1983 Act 393, Wisconsin joined six other states (Indiana, Iowa, Michigan, Minnesota, Missouri and Ohio) in the Midwest Interstate Low-Level Radioactive Waste Compact Commission for the purpose of developing a low-level radioactive waste disposal site in the Midwest. Within the next year, the Commission must choose which of the seven member states will host

the first regional disposal facility. If no state volunteers, the Commission will select the first host state in 1987 and the host state must then select a site. Enclosed is a description of the Compact's low-level radioactive waste program and a summary of the Commission's Draft Regional Management Plan.
