Section 115.367 of the Wisconsin Statutes deals with grants for Education for Employment projects. Subsection 4 (Nonstatutory Provisions) states:

The state superintendent of public instruction shall conduct a study of the effectiveness of the projects funded under section 115.367 of the statutes in meeting their objectives and by January 15, 1987, submit a report summarizing the findings of the study to the governor and to the chief clerk of each house of the legislature for distribution to the appropriate standing

This letter is an official transmittal of the report called for in the statute. The report can be viewed as an interim account of the five highly successful projects. The Wisconsin initiative, in fact, has been called a model for Education for Employment by other Chief State School Officers.

Thank you for your attention to this document. Rest assured that you will receive periodic updates of these

pilots as they continue their very important work. Your support of public education in Wisconsin is appreciated.

To the Honorable the Legislature

S. Rule 94(2) directs the reprinting of the rules of the Senate in pamphlet form after the Senate's adoption of any resolution changing the rules. S. Rule 94(1) directs that, for such pamphlet printing, any references contained in the Senate rules to "provision of the constitution, statutes or joint rules" shall be revised to conform to the numbers then assigned to such provisions.

When you notify me that no further rule changes are likely to be agreed to by the Senate in the immediate future, I will send a new pamphlet edition of the Senate rules, "as last amended by 1987 Senate Resolution 2", to the contract printer to be delivered in 1500 copies.

In compliance with the directives of S. Rule 94, the following cross-reference changes have been incorporated into the new pamphlet:

S. Rule 4(10): from statute "227.018 (2)" to "227.19".

S. Rule 27(1): from statute "227.018" to "227.19(4)(b)".

S. Rule 41(1)(d): from statute "13.56 (2)(h) or 227.018 (5)(e)" to "227.19 (5)(e) or 227.26 (2)(f)" and from joint rule "82 (2)(a)" to "83 (2)".

Although S. Rule 94 does not mention cross-reference corrections to senate rules, I have also corrected S. Rule 67(1) from senate rule "74" to "75".

So as to provide a permanent record of the corrections made, please print this letter in the Senate Journal and file the original in the jacket of 1987 Senate Resolution 2. That way, the following entry can be added to the official history shown on the jacket (and will be reflected with a journal page reference in the Bulletin of Proceedings);

"Cross reference corrections under S. rule 94(1)".
