On the question on bills and resolutions ready for a 3rd reading in cases where a minimum affirmative vote or special quorum is required by constitution, statutes, rules or otherwise, and when there are permanent vacancies in the senate, the membership presently serving shall be the basis for determining such minimum affirmative vote or special quorum."

It is clear that with 3 permanent vacancies in the Senate at this time, 16 affirmative votes are required for final adoption of a joint resolution proposing amendments to the State Constitution. To order a joint resolution to a third reading only a majority of those present and voting, as long as a quorum is present, may order a joint resolution to a third reading.
