Relating to federalizing the individual income tax, reducing the individual income tax rates, providing for a withholding study and defining 'internal revenue code'; an alternative minimum tax; the internal revenue code used in calculating the minimum tax; community development authority bonds; small income and franchise tax refunds and balances; technical changes to the individual income tax necessitated by marital property law; nonwithholding of tax on exempt remuneration; notice by the department of revenue about the effects of marital property agreements; federalizing

the corporate income and franchise taxes; the taxation of tax-option corporations and their shareholders; the income and franchise tax credit for sales and use taxes paid for fuel and electricity used in manufacturing; agreements about the payment of real property taxes; the payroll factor used to apportion corporate income for the income and franchise taxes; the definition of 'public utility' used in apportioning corporate income for income and franchise tax purposes; disallowing an income tax deduction for taxes for estates and trusts and deducting administrative expenses on fiduciaries' income tax returns and inheritance tax returns; the inheritance tax exemptions for contributions to cemeteries; a sales tax exemption for close-out sales by persons holding seller's permits, the use tax exemption for persons moving to this state, the sales tax on servicing certain property owned by nonresidents, a credit against the local sales tax for contractors and owners of certain property for local sales taxes paid in another state, repeals of local sales taxes; imposing the sales and use taxes on occasional sales of all-terrain vehicles and temporary sellers' permits; a sales and use tax exemption for wood waste used for fuel by businesses; clarifying that payment of telephone license fees is a license to do business for the year when the fee is paid, the definition of 'telephone company' and the distinction between toll and exchange revenue for the license fees imposed on telephone companies, the time period after which unpaid telephone company license fees become delinquent, and one of the rates for the license fees on telephone companies' toll business revenue; the real estate transfer fee and return in regard to conveyances involving units of government; the proceeds of tax sales; a special tax on built-in gains on property distributions of certain taxoption corporations; the taxation of certain federal property; phasing-out the inheritance tax and the gift tax; granting rule-making authority; and making an appropriation.
