REPORT OF JOINT SURVEY COMMITTEE ON RETIREMENT SYSTEMS

Appendix to Senate Bill 19

Public Policy Involved

Prior to 1971, the three retirement funds administered by the state each had separate and different provisions for the crediting of military services. A major study by the Retirement Research Committee in 1970 recommended new standards for crediting military service, and these standards were enacted by the 1971 legislature. This legislation defined the specific branches of U.S. armed forces which would qualify for credit and also specified that such service must be a break in public employment. These provisions are now found under 40.02 (15)(a) and (b), Stats.

The crediting of military service was significantly expanded in 1971 when state employee participants under the WRF were granted credit for military service which was <u>not</u> a break in public employment, if the participant had 20 years of regular creditable service. This same provision was extended in 1973 to all other participants under the old WRF, but teacher participants were not granted the same rights until the retirement fund merger act became effective on January 1, 1982. These provisions were again modified in 1983 when the 20-year requirement for such service credit was modified.

Presently, the WRS is nearly unique in the granting of credit for military service which is not a break in public employment, at no cost to the employee. Other public systems across the country may allow such service credit, but they usually require some employee contribution towards the costs involved. This bill would expand the crediting of military service (at no cost the employee) for an unknown number of active WRS participants.

Federal law reflects a Congressional policy of encouraging and rewarding military reserve service. Title 10 U.S.C. s 1336 provides:

"No period of service included wholly or in part in determining a person's right to, or the amount of, retired pay under this chapter (10 U.S.C. xx 1331 et seq.) may be excluded in determining his eligibility for any annuity, pension, or old-age benefit, under any other law, on account of civilian employment by the United States or otherwise, or in determining the amount payable under that law, if that serve is otherwise properly credited under it."

Court cases in California (Cantwell v. County v of San Mateo - 1980) indicate that public retirement systems are governed by the supremacy doctrine, and that federal law encouraging reserve service and preventing discrimination based upon such service does apply to state and local pension systems. Accordingly, it would appear that WRS law may be in conflict with federal law if military service credit is not granted because of a military pension based upon reserve service. This bill would bring the WRS into compliant with federal law.

This legislation would not apply to any employee qualifying for a military pension because of a career in the military services.
