## STATE OF WISCONSIN CLAIMS BOARD

The State Claims Board conducted a hearing at the State Capitol Building, Madison, Wisconsin on June 4, 1987. upon the following claim:

#### THE BOARD FINDS:

1. Marvin and Carol Wagner of Wautoma claim \$76,508.70 for property damage, income loss, miscellaneous expenses, barnyard replacement and pain and suffering relating to a fire on their farm in Waushara County on June 2, 1984, allegedly started by a foster child living in claimant's home. As a result of the fire, claimants allege the loss of two barns, small animal housing, nursery and calf raising space, a shop and machine shed, tools and stored supplies, 11 dairy heifers, a feed mill, bedding, hay, a paved cow lot and the family dog. Claimant's received \$11,774.30 from their private insurance carrier and \$5,000 from a Department of Health and Social Services insurance policy in effect at the time of the incident, for the damage to their property. The Board recommends the claim be paid in the reduced amount of \$15,170.70, representing \$4,800.00 to replace the barnyard, \$8,270.70 for uninsured property damage and \$2,100.00 for out-of-pocket clean up costs, based on equitable principles. The Board further recommends under authority of s. 16.007(6m), Stats, payment should be made from the Department of Health and Social Services appropriation s. 20.435(4)(cf), Stats. Separate opinion by members Wilker and Schneider: Member Wilker and Schneider concur in payment of the claim but are of the opinion that the recommended amount should be higher.

## THE BOARD RECOMMENDS:

1. Payment of \$15,170.70 to Marvin and Carol Wagner for reimbursement of out-of-pocket expenses resulting from the fire on their farm, caused by a foster child living in their home in 1984.
