The 1986-87 Research Council Progress Report, A Course of Action to Assess Acid Rain in Wisconsin,

summarizes the Research Council's recommendations on acid deposition research and monitoring priorities, funding levels, and sources of funding. The Council plans to examine further alternate research funding sources and to issue and addendum in September, 1987.

research and monitoring program.
