REPORT OF JOINT SURVEY COMMITTEE ON RETIREMENT SYSTEMS

Appendix to Senate Bill 361

Public Policy Involved

Provisions in this bill relating to the state executive retirement plan were also found in 1987 Assembly Bill 454. This bill was given a favorable recommendation by the JSCRS and passed both houses of the legislature. However, it was vetoed by the Governor presumably on the grounds that such changes ought to be part of a comprehensive bill. Accordingly, the JSCRS and the legislature have already determined that these provisions are good public policy.

The provisions in this bill relating to the repeal of the multiplier reduction for protectives who remain in such service after reaching the normal retirement age are also found in all of the comprehensive retirement packages introduced to date and also in Assembly Bill 608. The JSCRS has already recommended these provisions as good public policy relative to 1987 Assembly Bills 608, 265 and 462.

The other changes in this bill relating to mandatory distribution upon reaching age 70 1/2, Federal maximum limitations on benefits payable from defined-benefit plans, and technical changes relating to social security are all mandated by Federal law and must be complied with in order to protect WRS participants and the qualified status of the WRS.
