To the Honorable, the Senate:

This report has been prepared pursuant to Section 3026 (lm), 1987 Wisconsin Act 27 under the Direction of the Higher Educational Aids Board, the Department of Justice, and the Department of Administration, Division of State Executive Budget and Planning.

The investment banking firm of Smith Barney, Harris Upham and Co. Incorporated of New York and the law firm of Foley and Lardner of Milwaukee were engaged to examine the economic and legal issues, respectively, of the alternatives studied were:

> - Selling all guaranteed student loans made by the higher educational aids board under section 39.32 of the statutes, pursuant to section 39.28 (4) of the statutes, and in accordance with all resolutions of the building commission.

> - Refinancing outstanding revenue bonds that the higher educational aids board issued under section 39.37 (1) of the statutes, in accordance with subchapter II of chapter 18 of the statutes, to fund student loans under section 39.32 of the statutes.

> - Take no action under either of the above alternatives and continue to operate the program as it is currently constituted.

- Replace bondholder security of excess investment assets held under the bond resolutions with bond insurance.

The study indicated that, while there are some economic variations induced by changes in market conditions that effect the various securities transactions each alternative requires. Even the Alternative of taking no action must take into account assumptions regarding future investment rates of cash assets and restrictions on investment rates imposed by federal tax law. The caveat to the user of this report is that it was prepared using assumptions may have changed by the time a transaction is undertaken. It is believed, however, that the report will give guidance in the decision making process.
