## **EXECUTIVE COMMUNICATIONS**

To the Honorable, the Senate:

This letter transmits my recommendation for a Stripper oil overcharge program (Job-Ride). Wisconsin Statute 14.065 entitles the Senate Rsources and Elections Committee and the Assembly Environmental Resources and Utilities Committee to 30 days to review and comment on this program before the Joint Committee on Finance can act on my recommendatio. However, if these are able to complete their review prior to January 27, 1988, the Joint Committe on Finance can approve this program at their January 27th meeting.

This program provides \$100,000 to implement the Job-Ride program. The primary beneficiaries of this progrma would be low-income, minority unemployed or underemployed job seekers residing in Milwaukee's inner-city. Vans would be purchased to transport these citizens to jobs in the outlying areas. An attachment explains this program in greater detail.

The Job-Ride program merits legislative approval, because it responds in a creative new way to a growing major concern that our minority population has been cut off from needed mainstream job opportunities. This proirity job creation program can be immediately funded in addition to the programs I previously recommended in the Stripper II plan because Wisconsin has received this amount of additional Stripper monies.

I urge you to approve this program. I am absolutely committed to it as one effective way to help Wisconsin's unemployed and working poor gain access to new and better job opportunities.
