REPORT OF JOINT SURVEY COMMITTEE ON RETIREMENT SYSTEMS

Appendix to Senate Bill 317

Public Policy Involved

S.B. 317 presumably was introduced by groups representing the interests of annuitants under the WRS. Currently, there are about 190,000 actively employed participants under the WRS, and 65,000 annuitants—a ratio of three to one. Presently, the RRC, the ETFB and the SIB have no members that by definition are annuitants under the WRS and represent the interest of annuitants. All three of these bodies do have members that represent active employees and also employers of these employees. The purpose of this legislation is to add members who will represent the interests of WRS annuitants.

The S.S.A. #1 to S.B. 317 has been introduced at the request of the ETF Board and represents the recommendations of that board and also the Wisconsin Retirement Board and Teachers Retirement Board—all actively involved in the administration of the WRS. The proposed changes continue the trend towards the election of members to the boards under the ETF and the state investment board in lieu of the appointive process. This legislation also makes those members who continue to be appointed by the Governor subject to Senate confirmation. The S.S.A. #1 to S.B. 317 also increases the level of expertise statutorily required of SIB members appointed by the Governor.

The S.S.A. #2 to S.B. 317 was introduced to answer some of the questions and concerns that were noted in various hearings on this legislation. This substitute amendment deletes several of the controversial amendments contained in the S.S.A. #1, clarifies the level of responsibility needed by investment board members who have equivalent investment experience from participation on other boards and committees, and continues most of the current law provisions governing conflict of interest for investment board members.

RECOMMENDATION

The Joint Survey Committee on Retirement Systems finds that the S.S.A. #2 to Senate Bill 317 reflects good public policy and recommends its passage.
