THE BOARD FINDS:

1. State Farm Insurance Company of Racine, Wisconsin, claims \$1,200.93 subrogation damages. Claimant's insured, Jerome Fliess, submitted a claim to the insurance company for damages to his vehicle allegedly caused by a resident of the Southern Wisconsin Center on August 10, 1987. The insurance company reimbursed its insured \$1,200.93 for the damages. Consistent with the long-standing policy of this Board concerning subrogation claims, the Board concludes the claim is not one for which the state is legally liable nor one which the state should assume and pay based on equitable principles.

2. Linnan Construction Company of Brookfield, Wisconsin, claims \$27,601.71 for unanticipated costs incurred in 1983 during a Department of Transportation bridge construction project on Bluemound Road in Milwaukee County. Claimant was the general contractor for the project. Claimant alleges the project plans prepared by the Department of Transportation were defective, misleading and failed to give adequate

notice to the contractor and subcontractor of the potential danger of the old abutments sliding into the excavation. The bid submitted by claimant did not include any expense for protecting an existing bridge abutment. After excavation was completed, the existing abutment collapsed requiring additional expenses. The Board concludes there has been an insufficient showing of negligence on the part of the state, its officers, agents or employes and this claim is not one for which the state is legally liable nor one which the state should assume and pay based on equitable principles.

3. James Schlaak of Wautoma, Wisconsin, Claims \$6,276.33 as the amount he paid for early withdrawal of his land from the forest crop law program. In 1969, claimant built a home on property that had been approved as forest cropland in 1957. Under the forest crop law, claimant was paying ten cents per acre in lieu of real estate taxes on his residence. Section 77.02 Stats., provides that lands which are used for residential purposes are not eligible for the special tax treatment of the forest crop law. In 1986, claimant alleges that the Department of Natural Resources pressured him to pay the back taxes on his residence from 1969 and that he was forced to sell his home in order to pay the taxes. The Board concludes there has been an insufficient showing of negligence on the part of the state, its officers, agents or employes and this claim is not one for which the state is legally liable nor one which the state should assume and pay based on equitable principles. (Member Schneider dissenting.)

4. Gerald Goepfert of Grantsburg, Wisconsin, claims \$10,000.00 for diminished property value and loss of use of property as a result of the flooding of his property in Burnett County during May, 1986. Claimant alleges the Department of Natural Resources improperly maintained and operated the dams on Whiskey and Hay Creeks in Burnett County, causing the flooding damage to his property. Between May 8, and May 14, 1986, 6.11 inches of rain fell following over 5 inches of rain that fell in April and a heavier than normal spring runoff. To reduce downstream flooding in the area of claimant's property, the Department of Natural Resources closed the water control gates at the Phantom flowage and other flowages for use as floodwater storage reservoirs. The Board concludes there has been an insufficient showing of negligence on the part of the state, its officers, agents or employes and this claim is not one for which the state is legally liable nor one which the state should assume and pay based on equitable principles.

5. Village of Bangor claims \$52,689.00 for the cost of constructing a pipe arch culvert in 1985 over a former railroad right of way acquired by the Department of Natural Resources for use as part of the La Crosse River State Recreational Trail. The Village determined that the old wooden bridge previously owned and maintained by the railroad was unsafe for traffic and replaced it with the pipe arch culvert. The wooden bridge spanned the state trail but the Department of Natural Resources did not purchase the bridge from the railroad company. The Board concludes there has been an insufficient showing

of negligence on the part of the state, its officers, agents or employes and this claim is not one for which the state is legally liable nor one which the state should assume and pay based on equitable principles.

6. Douglas Marth of Milwaukee, Wisconsin, claims \$79.77 for replacement of his coat allegedly stolen on November 20, 1987, from the coatrack at the Wisconsin Conservation Corps office in Milwaukee, where claimant is employed. The Board concludes there has been an insufficient showing of negligence on the part of the state, its officers, agents or employes and this claim is not one for which the state is legally liable nor one which the state should assume and pay based on equitable principles.

7. David Fronk of Hillsboro, Wisconsin, claims \$111.30 for the cost of repairing his vehicle allegedly damaged on December 12, 1987, at the Executive Residence. The oil pan on claimant's automobile was damaged when the bottom of his car scraped the gate block in the driveway at the Executive Residence. The gate block is approximately 3 1/2 inches high. The Board recommends the claim be paid in the reduced amount of \$75.00 based on equitable principles. The Board further concludes under authority of s. 16.007(6m), Stats., payment should be made from the Department of Administration appropriation s. 20.505(5)(ka), Stats. (Member Taffora not participating.)

8. Dennis Suiter of Beloit, Wisconsin, claims \$1,053.25 for replacement of the plumbing in his home allegedly necessitated by the failure of the Anaconda copper pipe which was installed by a plumbing contractor when the home was built in 1977. In 1984, sections of the pipe began to develop pin holes, resulting in leaking. In May, 1987, claimant replaced all of the plumbing in his home. Claimant contends the state is responsible because it had approved the use of the pipe. In 1976, Anaconda Company received experimental approval in the Wisconsin Administrative Code for the use of tube type D in sizes 1/2 or 3/4 inches OD copper. The approval, as listed in the Department of Industry, Labor and Human Relations' material bulletin, specifically indicated that acceptance for installation of use in the state was not to be construed as an endorsement or guarantee of the product. In 1984, the materials approval was removed because of numerous failures occurring in corrosive water areas which proved that type D copper failed prematurely. The Board concludes there has been an insufficient showing of negligence on the part of the state, its officers, agents or employes and this claim is not one for which the state is legally liable nor one which the state should assume and pay based on equitable principles.

9. Darlene Schumaker of Sturtevant, Wisconsin, claims \$100.00 for uninsured medical expenses allegedly resulting from her fall on September 2, 1987, on the sidewalk adjacent to the St. Bonaventure property owned by the Department of Health and Social Services. Claimant contends the fall was caused by mud and grass clippings on the sidewalk. The Board concludes the claim should be paid based on equitable principles. The

Board further concludes under authority of s. 16.007(6m), Stats., payment should be made from the Department of Health and Social Services appropriation s. 20.435(3)(a), Stats.

10. June Madden of Union Grove, Wisconsin, claims \$70.88 for damages to her vehicle allegedly incurred on September 26, 1987, while the vehicle was parked in the lot at the Southern Wisconsin Center. A resident of the Center ran into the car with a bicycle causing scratches to the right front bumper of the car. Claimant has full insurance coverage for the loss. The Board concludes there has been an insufficient showing of negligence on the part of the state, its officers, agents or employees and this claim is not one for which the state is legally liable nor one which the state should assume and pay based on equitable principles.

11. Julia Hornbostel of Beloit, Wisconsin, claims \$500.00 as payment for the use of an article she wrote on the history of Old Newport, Door County, Wisconsin which was published in the Newport State Park newspaper in 1986, without her knowledge or consent. In 1975, claimant submitted her article manuscript to the Department of Natural Resources for consideration as feature in the Department's magazine. In 1987, claimant discover that an excerpt from her article had been published in the 1986 state park brochure without her permission. The Board concludes the claim should be paid in the reduced amount of \$300.00 based on equitable principles. The Board further concludes under authority of s. 16.007(6m), Stats., payment should be made from the Department of Natural Resources appropriation s. 20.370(1)(mu), Stats.

12. Kirk Neese of Superior, Wisconsin, claims \$1,097.32 for the cost of a recreational motor vehicle which he purchased after being incorrectly advised by the Department of Natural Resources that the machine could legally be used as an all-terrain vehicle (ATV). However, the vehicle did not meet the requirements for an ATV in s. 340.01(2g), Stats., and could not be licensed as a motor vehicle for highway use or be used as an ATV in Wisconsin. The Board concludes the claim should be paid in the reduced of \$600.00 based on equitable principles. The Board further concludes under authority of s. 16.007(6m), Stats., payment should be made from the Department of Natural Resources appropriation s. 20.370(3)(mu), Stats.

13. Brian Stair of Waukesha, Wisconsin, claims \$623.31 for medical expenses and pain and suffering incurred as a result of an injury on August 3, 1987, when he stepped on a piece of barbed wire in his campsite at the Mirror Lake State Campground. The park personnel had no knowledge of the existence of the abandoned fence line in that area until this incident occurred. Claimant's medical expenses in the amount of \$101.31 were covered by insurance. The Board concludes there has been an insufficient showing of negligence on the part of the state, its officers, agents or employees and this claim is not one for which the state is legally liable nor one which the state should assume and pay based on equitable principles.
