THE BOARD FINDS:

- 1. Helen Silko of Lone Rock, Wisconsin, claims \$254.94 for the cost of repairing her vehicle's tail light which was damaged on January 13, 1988, when her vehicle hit the iron railing along the East Washington driveway at the State Capitol. Claimant had parked in the East Washington driveway to unload materials from her vehicle to carry to her office in the Capitol. Two trucks were parked in the driveway ahead of claimant's vehicle so she was unable to drive forward. Claimant alleges the driveway was icy causing her vehicle to slide into the railing when she backed up. concludes there has been an insufficient showing of negligence on the part of the state, its officers, agents or employes and this claim is not one for which the state is legally liable nor one which the state should assume and pay based on equitable principles.
- 2. Clipper Exxpress Company of Chicago, Illinois, claims \$159,150.00 for refund of franchise and income taxes assessed by the Department of Revenue as a result of an audit of the Company for the years 1977 through 1982. Claimant failed to respond or appeal the Department of Revenue's assessment within 60 days and the matter was referred to a collection agency in December, 1986. Claimant contends that a representative of the collection agency fraudulently advised claimant to pay the estimated tax assessment in order to preserve their appeal rights. On February 20,

1987, after claimant had paid the assessment, claimant submitted its tax records to the Department of Revenue and the correct amount of tax was determined to be \$252.00. The Board recommends the claim be paid in the reduced amount of \$119,095.50, based on equitable principles. The Board further concludes under authority of s. 16.007(6m), Stats., payment should be made from the Claims Board appropriation s. 20.505(4)(d), Stats.

- 3. John Bleier of Nekoosa, Wisconsin, claims \$3,158.00 for the difference between the cost of a conventional septic system and the mound septic system which he was required to install when building his home in Adams County in 1986. In May, 1986, claimant submitted a sanitary permit application to the Department of Industry, Labor and Human Relations, Safety and Buildings Division, for review. According to the soil borings and percolation tests, a mound sewage system was required for claimant's property. The Board concludes there has been an insufficient showing of negligence on the part of the state, its officers, agents or employes and this claim is not one for which the state is legally liable nor one which the state should assume and pay based on equitable principles. (Member Schneider dissenting.)
- James Lammer of Menomonie, Wisconsin, claims \$25,558.00 for loss of business allegedly due to a construction project at the University of Wisconsin-Stout during 1987. Claimant contends the excavation of the street in front of his store made access to his business difficult causing a loss of income during May, June and July, 1987. When excavation was completed, a bridge was constructed over the area to allow access to claimant's parking lot although it was less convenient for The Board concludes there has been an patrons. insufficient showing of negligence on the part of the state, its officers, agents or employes and this claim is not one for which the state is legally liable nor one which the state should assume and pay based on equitable principles.
- 5. Irene Wojciechowski of Milwaukee, Wisconsin, claims \$10,360.40 as compensation for medical expenses, pain, suffering and disability allegedly resulting from an injury she sustained on March 7, 1986, when she tripped and fell over a ramp in the lobby at the Waupun Correctional Institution. As result of the fall, claimant sustained a laceration over her right eye, bruises, headaches and broken eyeglasses. The Board concludes the claim should be paid in the reduced amount of \$1,000.00, based on equitable principles. The Board Further concludes under authority of s. 16.007(6m), Stats., payment should be made from the Claims Board appropriation s. 20.505(4)(d), Stats.

- 6. Madison Retriever Club of Madison, Wisconsin, claims \$2,737.00 for the cost of a fill project on Hook Lake in Dane County which was subsequently removed by the Department of Natural Resources in October, 1987. During the 1960's, claimant had placed fill on the lakebed of Hook Lake to create a walkway into the water for the purpose of training dogs. On September 4, 1986, claimant requested the Department of Natural Resources' permission to extend the walkway on Hook Lake. The Department of Natural Resources advised claimant they had no jurisdiction in the matter and referred claimant ot the Dane County Zoning Department. Dane County Zoning granted the request. On February 25, 1987, the Department of Natural Resources requested that claimant stop work on the project and then later gave permission to complete the project. Subsequently, the Department of Natural Resources advised claimant they had erred in giving permission to complete the walkway and the Department removed the fill at a cost of \$460.00. The Board concludes the claim should be paid in the reduced amount of \$1,000.00 based n equitable principles. The Board further concludes under authority of s. 16.007(6m), Stats., payment should be made from the Department of Natural Resources appropriation s. 20.370(8)(ma), Stats.
- 7. Tiller Furniture Plaza of Prairie du Chien, Wisconsin, claims \$4,651.02 for damages caused by a wild deer which jumped through two plate glass windows of the store, damaging property in the store on January 10, 1988. Even though legal title to all wild animals in Wisconsin is vested in the state pursuant to s. 29.02(1), Stats., mere owner ship does not create legal liability for damages caused by wild animals. The Board concludes there has been an insufficient showing of negligence on the part of the state, its officers, agents or employes and this claim is not one for which the state is legally liable nor one which the state should assume and pay based on equitable principles. (Member Schneider dissenting.)
- 8. Stanley Henry of Platteville, Wisconsin, claims \$105.00 for the cost of towing a wagon and combine from his cornfield on November 9, 1987. Claimant alleges the wagon and combine became stuck because of a beaver den under his field. Even though legal title to all wild animals in Wisconsin is vested in the state pursuant to s. 29.02(1), Stats., mere ownership does not create legal liability for damages caused by wild animals. The Board concludes there has been an insufficient showing of negligence on the part of the state, its officers, agents or employes and this claim is not one for which the state is legally liable nor one which the state should assume and pay based on equitable principles.
- 9. David Bosely of Des Plaines, Illinois, claims \$435.00 for dental expenses to repair a tooth allegedly broken while he was eating a bratwurst sandwich at the Clausing Barn Restaurant at Old World Wisconsin on October 16, 1987. Claimant alleges there was something hard in the sandwich which caused his toot to break. However, the bratwurst was examined after this incident

- and there was no evidence of any foreign object in the food. The Board concludes there has been an insufficient showing of negligence on the part of the state, its officers, agents or employes ant this claim is not one for which the state is legally liable nor one which the state should assume and pay based on equitable principles.
- 10. Donna Marinelli of Greendale, Wisconsin, claims \$7,867.18 for sales tax erroneously paid in 1979, 1980 and 1981, on the income from her coin operated laundromat. Claimant's laundromat business is exempt from sales tax pursuant to s. 77.52(2)(a) 6, Stats. However, any claim for refund must be filed within four years of the date the tax was due pursuant to s. 77.59(4), Stats. The Board concludes there has been an insufficient showing of negligence on the part of the state, its officers, agents or employes and this claim is not one for which the state is legally liable nor one which the state should assume and pay based on equitable principles. (Member Schneider dissenting).
- 11. Jerome Evenson of Menomonie, Wisconsin, claims \$592.50 for loss of pasture rent and a one acre field of alfalfa allegedly due to the construction on Highway 25 in Dunn County from May 15, through November, 1987. The Board concludes there has been an insufficient showing of negligence on the part of the state, its officers, agents or employes and this claim is not one for which the state is legally liable nor one which the state should assume and pay based on equitable principles.
- 12. April Schiessl of Milwaukee, Wisconsin, claims \$231.00 on behalf of Lend Lease Cars, Inc., for damages to their vehicle which she was driving on April 29, 1987. A yellow substance was sprayed on the car as she was driving on I 90-94 behind a state highway vehicle. The Board concludes the claim should be paid, by check issued jointly to claimant and Lend Lease Cars, based on equitable principles. The Board further concludes under authority of s. 16.007(6m), Stats., payment should be made from the Department of Transportation appropriation s. 20.395(3)(hq), Stats.
